15. GOVERNING LAW; SEVERABILITY

If Lender requires immediate payment in full or if I abandon the Property. 20. LOST, STOLEN OR MUTILATED DOCUMENTS

If any of the Loin Documents are lost, stolen, mutilated or destroyed and Lender delivers to me an indentification in my favor, signed by Lender, then I will sign and deliver to Lender a Loan Document identical in form and content which will have the effect of the original for all purposes.

21. WAIVER OF STATUTE OF LIMITATIONS

I will waive, within applicable law, the pleading of the statute of limitations as a defense to enforce this Security instrument, including any obligations referred to in this Security Instrument or Secured Notes.

22. CAPTIONS

The captions and headings at the beginning of each paragraph of this Security Instrument are for reference only and will not be used in the interpretation of any provision of this Security Instrument.

23. MODIFICATION

This Security Instrument may be modified or amended only by an agreement in writing signed by Borrower and Lender.

24. CONDOMINIUM, COOPERATIVE AND PLANNED UNIT DEVELOPMENT OBLIGATIONS

if the Property is a unit in a condominium, cooperative or planned unit development, each of which shall be called the "Project," and I have an increas in the common elements of the Project, then Lender and I agree that:
