13) Based on the foregoing, decedent left surviving as her heirs the following: Barbara Nunley and Jewel Vivian White, her daughters.

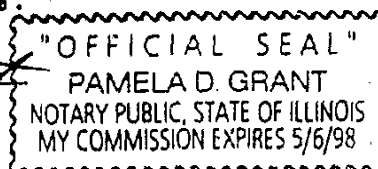

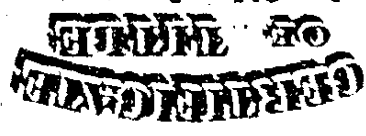
