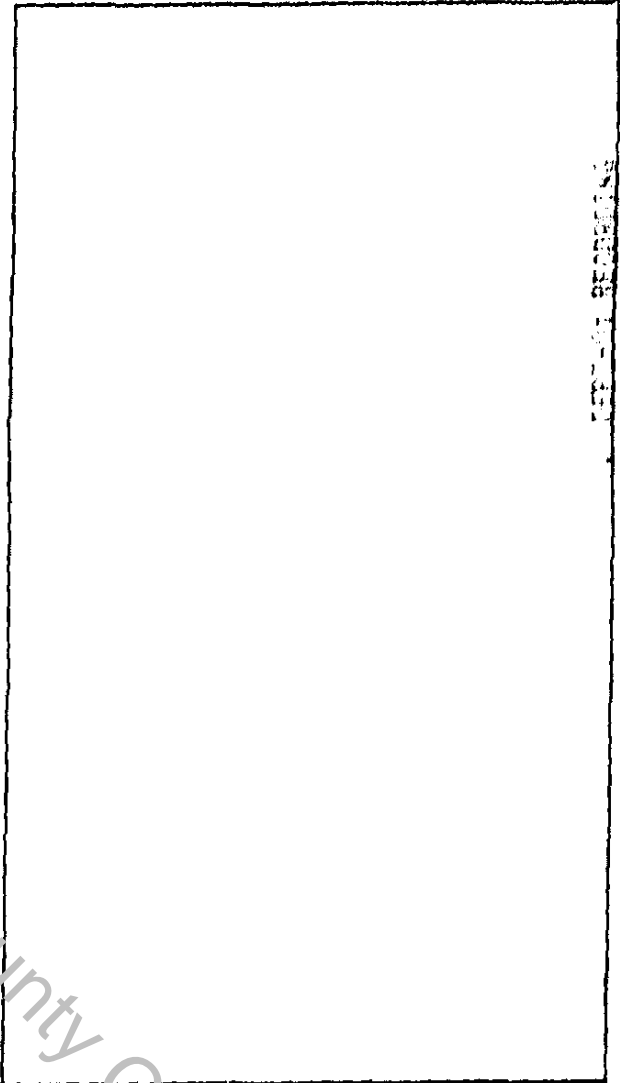


PARTIAL RELEASE

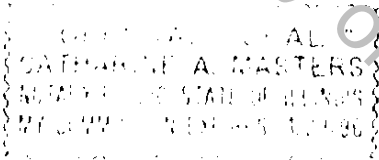
