AND, IT IS FURTHER ORDERED that the judgment(s) hereby entered on the date(s) of 9-15-94 in the total amount(s) of \$ 600.00 plus \$60.00 in court costs against defendant(s) LUIS HERNANDEZ 3150 W. CEAMK RD. CHICAGO, ILL shall stand as final judgment(s) and that leave for enforcement on said judgment(s) is granted Plaintiff, CITY OF CHICAGO, instant.

Count II is hereby dismissed without prejudice.

AND IT IS FURTHER ORDERED that a Mandatory Permanent Injunction issue against defendant(s) LUIS HERNANDEZ his/her/their agents, heirs successors or assigns, to fully comply the open City of Chicago Building Violations in this Cause, stated above.
