AGREEMENT TO TERMINATE PUBLIC RIGHT-OF-WAY VACATION AGREEMENT (BLUM PROPERTY)

THIS AGREEMENT is dated as of the 10th day of January, 1995, and is by, between, and among the VILLAGE OF NORTHBROOK, an illinois home rule municipal corporation (the "Village"), and COLE TAYLOR BANK, AS SUCCESSOR TO HARRIS TRUST AND SAVINGS PANK, as Trustee under Trust Agreement dated November 18, 1966 and known as Trust No. 32559 (the "Owner").

IN CONSIDERATION OF the recitals and the mutual covenants and agreements set forth herein and pursuant to the Village's home rule powers and all other applicable laws, specifically including, but with limitation 65 ILCS 5/11-74.3-1 et seq., the parties hereto agree as follows:

SECTION 1. RECITALS.

- A. The Owner is the record title cwner of that certain tract of property consisting of approximately 1.3 acres and generally located on the east side of Skokie Boulevard south of Lake-Cook Road (the "Subject Property").
- B. The Village and the Owner have previously entered into that certain Public Right-of-Way Vacation Agreement dated as of December 22, 1992 and recorded or January 28, 1993 as Document No. 93072576 (the "Public Right-of-Way Vacation Agreement"). The Public Right-of-Way Vacation Agreement, among other things, imposed certain development requirements related to the Subject Property and surrounding tracts of land.
- C. Pursuant to Resolution No. 95-R-3, the Village approved a Development and Property Maintenance Agreement (the "Development Agreement") pursuant to which ORIX TMK Northbrook Venture II ("TMK II") has agreed, among other things, to develop the Subject Property and surrounding land pursuant to the terms and provisions of the Development Agreement. TMK II is the contract purchaser of the Subject Property.

D. In light of TMK II's pending acquisition of the Subject Property and the proposed development of the Subject Property pursuant to the Development Agreement, the Owner and the Village have agreed to enter into this Agreement to terminate the Public Right-of-Way Vacation Agreement.

SECTION 2. TERMINATION OF VACATION AGREEMENT.

The parties do hereby terminate the Public Right-of-Way Vacation Agreement in its entirety.

SECTION 3 COMPLETE AGREEMENT; SUPERSEDENCE.

This Agreement is the complete agreement between the parties regarding the Subject Property and supersedes and nullifies all prior drafts and agreements, including specifically, but without limitation, the Public Right-of-Way Vacation Agreement.

SECTION 4. EFFECTIVE DATE.

This Agreement shall be effective upon but not before, the date on which it has been fully executed by all parties hereto.

IN WITNESS WHEREOF, the parties have set their hands and affixed their seals on the date first above written, the same being done after public hearing, notice, and statutory requirements having been fulfilled.
