13. Loan Charges. G. ASSIGNMENT OF LEASES. Upon Lender's request, Borrower shall assign to Lender all leases of the Property and all security deposits made in connection with leases of the Property. However, Borrower shall receive the Rents until (i) Lender has given Borrower notice of default pursuant to paragraph 21 of the Security Instrument and (ii) Lender has given notice to be tenant(s) that the Rents are to be paid to Lender or Lender's agent. This assignment of Rents constitutes an absolute assignment and not an assignment for additional security only.

If Lender gives notice of breach to Borrower: (i) all Rents received by Borrower shall be held by Borrower as trustee for the benefit of Lander only, to be applied to the sums secured by the Security Instrument; (ii) Lender shall be entitled to collect and receive all of the Rents of the Property; (iii) Horrower agrees that each tenant of the Property shall pay all Rents due and unpuid to Lender or Lender's agents upon Lender's written demand to the legant; (iv) unless applicable law provides otherwise, all Rents collected by Lender or Lander's agents shall be applied first to the costs of taking control of and managing the Property and collecting the Rents, including, but not limited to, attorneys' fees, receiver's fees, premiums on receiver's bonds, repair and maintenance costs, insurance premiums, taxes, assessments and other charges on the Property, and then to the sums secured by the Security Instrument; (v) Lender, Lender's agents or any judicially appointed receiver shall be lighted to account for only those Rents actually received; and (vi) Lender shall be entitled to have a receiver appointed to take possession of and manage the Property and collect the Rents and profits derived from the 'roperty without any showing as to the inadequacy of the

If the Rents of the Property are not sufficient the costs of taking control of and managing the Property and of collecting the Rents any funds expended by Lender for such purposes shall become indebtedness of Borrower to Lender secured by the Security instrument pursuant to Uniform Covenant 7.

Borrower represents and warrants that Borrower has not executed any prior assignment of the Rents

and has not and will not perform any act that would proven Lender from exercising its rights under this

paragraph.

Lender, or Lender's agents or a judicially appointed receiver, sivil not be required to enter upon, take control of or maintain the Property before or after giving notice of de apt to Borrower. However, Lender, or Lender's agents or a judicially appointed receiver, may do so at any divid when a default occurs. Any application of Rents shall not cure or waive any default or invalidate any other right or remedy of Lender. This assignment of Rents of the Property shall terminate when all the sums secured by the Security Instrument are paid in full.

1. CROSS-DEFAULT PROVISION. Borrower's default or breach under any lete or agreement in which Lender has an interest shall be a breach under the Security Instrument and Lender any invoke any of the remedies permitted by the Security Instrument.
