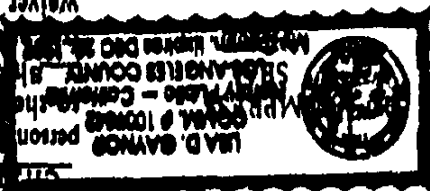

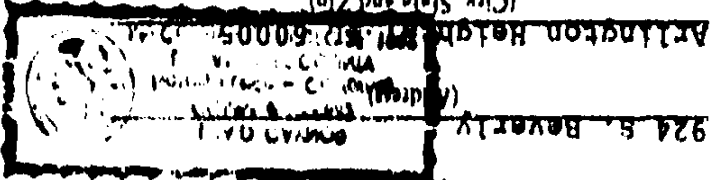

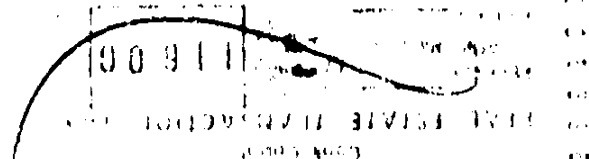

### Change of Information

#### Scannable document - read the following rules
