TOOFTHER with all the improvements now or hereafter creeted on the property, any, and all easements, rights, appartenances and rents all of which shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the teasehold estate if this Mortgage is on a leasehold) are hereinafter referred to as the 'Property."
