This deed is subject to:

4. covenants, conditions, restrictions of record provided the same do not unreasonably interfere with Purchaser's use and enjoyment of the Condominium;
5. applicable zoning and building laws, ordinances and restrictions provided the same do not unreasonably interfere with Purchaser's use and enjoyment of the Condominium;
6. title exceptions pertaining to liens or encumbrances of a definite or ascertainable amount which may be removed by the payment of money at the time of Closing and which the Seller shall so remove at that time by using the funds to be paid upon delivery of the Deed;
7. matters over which the Escrowee is willing to insure;
8. acts done or suffered by the Purchaser; and
9. Purchaser's mortgage.
