- (3) Consent to any assignment of the interest of the tenant in any lease, or to any sub-leviling thereof;
- (4) Accept any rent payable under any lease in advance of the time when the same is payable under the terms thereof; and any of the above acts, if done without the written consent of the Assignee, shall be null and void.
- (5) Permit any lease to come before the Nortcage and shall subordinate all such leases to the liens of the Morigage.

Concerning each such lease, Assignor further coverants, warrants and represents that, except as heretofore disclosed in writing to Assignee, there are no defaults now existing under any such leases nor is there any state of facts which with the giving of notice or lapse of time or both, could constitute a default under any such lease and further that Assignor shall promptly notify Assignee of any notice received by Assignor claiming that a default has occurred under any such lease on the part of Assignor.
