(C)Borrower's Promises. You promise to:

- (1)Pay all amounts when due under your Agreement, including interest, and to perform all duties of the loan agreement and/or this Mortgage.
- (2)Pay all taxes, assessments and hens that are assessed against the Property when they are due. If you do not pay the taxes, assessments or hens, we can pay them, if we choose, and add what we have paid to the amount you owe us under your Agreement with interest to be paid as provided in that Agreement.
- (ONot execute any mortgage, security agreement, assignment of leases and rentals or other agreement granting a hen against your interest in the property without our prior written consent, and then only when the document granting that lien expressly provides that it shall be subject to the hon of this Mortgage.
- (4)Keep the Property in good repair and not damage, destroy or substantially change the Property.
- (5) Keep the Property insured against loss or damage caused by fire or other hazards with an insurance carrier acceptable to us. The insurance policy must be payable to us and name us as Insured Mortgages for the amount of your foan. You must deliver a copy of the policy to us if we request it. If you do not obtain insurance, or pay the premiums, we may do so and add what we have paid to the amount you owe us under your Agreement with interest to be paid as provided in the loan agreement. You shall promptly give us written notice of any investigation, claim, demand, lawsuit or other action by any governmental or regulatory agency or private party involving the Property or release of any hazardous substance on the Property. If you are notified by any governmental or regulatory authority that any removal or other remediation of any hazardous substance affecting the Property is necessary, you shall promptly take all necessary remedial actions in accordance with applicable environmental laws.

- Mortgage or you fail to meet the promises you made in this Mortgage or you fail to meet the terms of your Agreement, you will be in default. If you are in default, we may use any of the rights or remedies stated in your Agreement including, but not limited to, those stated in the Default, Remedies on Default, and/or Reducing the Credit I unit paragraphs or as otherwise provided by applicable law. If we accelerate your outstanding balance and demand payment in tull, you give us the power and authority to sell the property according to procedures allowed by law. You will allow us to inspect the Property on reasonable notice. This shall include the right to perform any environmental proceedingstion that we deem necessary and to perform any er visonmental remediation required under environmental law. Any investigation or remediation will be conducted solely for our benefit and to protect our interests. If any term of this Mortgage is found to be illegal or unenforceable, the other terms will will be in effect. This Agreement may secure "revolving crean" as defined in 815 ILCS 205/4.). The revolving credit line shall be governed by and construed in accordance with the Illinois Financial Services Development Act, 175 ILCS 675/1, et. se a Upon or at any time after the filing of a complaint to forcelose this mortgage, we shall be entitled to enter upon, take possission of and manage the Property and collect rents in person, by agent or by judicially appointed receiver without notice and orfore or after any judicial sale. You agree to pay all of our fees including attorney's fees, receiver's fees and court costs upon the filing of a foreclosure complaint.
