LIMITED POWER OF ATTORNEY

- (2) Filing, processing claims and accepting claim proceeds from mortgage insurance or loan guarantee claims paid under the National Housing Net of 1949 or Chapter 37 of Title 38 of the United States Code and otherwise complying with related from the regulations, and endorsing to the order of Servicer any checks that are nade payable to the order of Bankers;
- (3) Appearing, litigating, and compromising any matter in any cetar; including but not limited to U.S. Bankruptcy Courts, and executing and filing all papers in connection therewith, provided however, Servicer shall not be authorized to commence any proceedings other than foreclosure, bankruptcy and eviction without written consent of Bankers;
- (4) Selling, transferring or disposing of real property acquired through foreclosure or otherwise, and executing all contracts, agreements, deeds, assignments or other instruments agreessary to effect such sale, transfer or disposition and receive proceeds checks made payable to the order of Bankers, assigning the right to any deficiency judgment, and/or deficiency claim or sale bid incidental to a forcelosure or defaulted loan;
- (5) Preparing, executing and delivering satisfactions, cancellations, discharges, full or partial releases of lien, and UCC continuation financing statements; entering into and executing assumption agreements; appointing substitute trustee;
- (6) Preparing, executing and delivering deeds to yest title to properties in the Secretary of Housing and Urban Development of Washington, D.C., or the Secretary of Veterans' Affairs;
