EXTENSION AGREEMENT

This AGREEMENT entered into this 23rd day of March 1995 by and between HOWARD SHAPIRO AND MICHAEL DEB SHAPIRO his wife hereinafter called "MORTGAGOR", and THE FIRST NATIONAL BANK OF LINCOLNWOOD, hereinafter called "MORTGACHEE":

WITNESSETH:

WHEREAS, on APRIL 22, 1988, MORTGAGOR executed a Equity Agreement and Disclosure and a First Credit Equity Line Mortgage for a Line of Credit in the amount of FIFTY THOUSAND AND 00/100..... DOLLARS (\$50,000.00) payable on APRIL 29, 1995 to MORTGACHEE, and said FIRST CREDIT EQUITY LINE MORTGAGE was recorded on MAY 3, 1988 in the office of the RECORDER OF DEEDS in the County of COOK, State of Illinois, as Document No. 88187217, covering the following described premises:

LOT 21 (EXCEPT THE SOUTH 16-1/2 FEET THEREOF) AND ALL OF LOT 22 IN BLOCK 9 IN DEVON McCORMICK BLVD. ADDITION TO ROCHERS PARK IN THE SOUTH EAST 1/4 OF SECTION 35, TOWNSHIP 41 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

WHEREAS, the Line of Credit comes due on APRIL 29, 1995 and

WHEREAS, the MORTGAGOR has requested that the due date of said Line of Credit be extended and has consented to adding a provision to increase the rate in the event the loan is in default and consented to a further provision to clarify that the interest is computed on a 365 day year, which request has been granted by the MORTGACHEE, and

WHEREAS, MORTGACHEE, under the Equity Line Mortgage described above has agreed to this extension.

NOW THEREFORE, it is hereby agreed by and between said MORTGAGOR and MORTGACHEE as follows:

- 1) The EQUITY AGREEMENT AND DISCLOSURE is hereby extended to add the following provisions:
 - a) Interest will be computed based upon a 365 day year for the actual number of days elapsed.
 - b) At the end of the first paragraph entitled "PAYMENTS" The Finance Charge shall increase to a rate per annum equal to the sum of the interest rate index in effect each day plus 5.00%, which rate shall change when and as the interest rate index changes. If the minimum payment is not received by the due date or there is any other default that occurs under the paragraph entitled "Termination and/or Acceleration".
- 2) The full amount of all unpaid loans and interest outstanding under MORTGAGOR'S Line of Credit as set forth in the EQUITY AGREEMENT AND DISCLOSURE and the FIRST CREDIT EQUITY LINE MORTGAGE shall be extended to APRIL 29, 2002.
- 3) All of the provisions of the EQUITY AGREEMENT AND DISCLOSURE and the FIRST CREDIT EQUITY LINE MORTGAGE shall remain in full force and effect and be binding on the Parties hereto except as herein expressly modified.




