Property of Cook County Clerk's Office

In accordance with the Illinois Constitution, the State of Illinois, and the Constitution of the United States, the people have the right to keep and bear arms for self-defense and other lawful purposes.

No person shall be compelled to give up his/her gun or other firearms during a search or arrest unless he/she has been lawfully arrested and there is probable cause to believe that he/she has committed a felony or other offense.

It is illegal to carry a concealed weapon without a permit. If you are carrying a concealed weapon, you must have a valid permit issued by the Illinois Department of Natural Resources.


