RELEASE OF MORTGAGE

THE CONNECTICUT BANK AND TRUST COMPANY, NATIONAL ASSOCIATION, of Hartford, Connecticut, in consideration of One Million Seven Hundred Thousand (\$1,700,000.00), does hereby remise, convey, release and quitclaim unto LASALLE NATIONAL BANK, a National Banking Association, not personally or individually but solely as Trustee under Trust Agreement dated March 25, 1969 and known as Trust No.38835, of the City of Chicago, County of Cook, and State of Illinois, all the right, title, and interest it may have acquired by a Mortgage, dated the 25th day of March 1969, and recorded in the Recorder's Office of Cook County, Illinois, in Document No.21146264, to the premises therein described:

That part of Blocks 1 and 2 and Lots 5, 6, 7, 8, 9, 10, 11, 12, 13 and 14, taken as a tract, in Subdivision of the South half of Section 24, Township 39 North, Range 12, East of the Third Principal Meridian, described as follows: Commencing at the intersection of the Easterly line of Des Plaines Avenue and a line which is 540.65 feet South of and parallel with the North line of said Blocks 1 and 2; thence Southerly along the Easterly line of said Des Plaines Avenue 400.72 feet to the place of beginning; thence East along a line parallel to the North line of said Blocks 1 and 2, 507.58 feet; thence South along a line which forms an interior angle of 89 12' with the last described course, 473.25 feet; thence Southwesterly along a line which forms an interior angle of 92 11' with the last described course, 585.0 feet; thence Westerly along a line which is perpendicular to the Easterly line of Des Plaines Avenue, 163.0 feet to said Easterly line of Des Plaines Avenue; thence Northeasterly along the Easterly line of Des Plaines Avenue, 525.09 feet to a bend in said Easterly line of Des Plaines Avenue; thence Northerly along the Easterly line of Des Plaines Avenue, 4.31 feet to the place of beginning, containing 319,000.00 square feet.
