Mortgagor hereby directs all insurers under such policies of insurance to pay all proceeds payable thereunder to Mortgagee as its interests may appear and hereby authorizes Mortgagee to make, settle and adjust claims under such policies of insurance and endorse the name of Mortgagor on any check, draft, instrument or other item of payment for the proceeds of such policies of insurance. In the event of loss or

damage, Mortgagee shall, after deducting the costs of collection thereof, if any, make the insurance proceeds available to Mortgager for repair and restoration, provided:

- (a) The proceeds are deposited with Mortgagee;
- (b) There is no default under the terms of the Note, this Mortgage or any other document evidencing or securing the Note (collectively referred to herein as the "Loan Documents") which has not been cured within the applicable grace period;
 - (c) The insurance carrier does not deny liability to a named insured;
- (d) Mortgagno shall be lurnished with an estimate of the costs of restoration accompanied by an architect's certification as to such costs and appropriate plans and specifications;
- (e) If the estimated costs of reconstruction shall exceed the proceeds available, Mortgagor shall furnish a bond of completion or such other evidence reasonably satisfactory to Mortgagee of Mortgagor's ability to meet such excess costs;
- Mortgagee's discretion, through an escrow at a title company of Mortgagee's choice, or upon an architect's certification as to the cost of the work done and evidence that there are no liens arising upon the reconstruction. - which extensions, modifications and new leases may provide for terms to expire, or for options to lessees to extend or renew terms to expire, beyond the maturity date of the Note and the date of issuance of a deed or deeds to a purchaser or purchasers at a foreclosure sale, it being understood and agreed that any such leases, and the options or other such provisions to be contained therein, shall be binding upon Mortgagor and all persons whose interest in the premises are subject to the lien hereof and to be binding also upon the purchaser or purchasers at any foreclosure sale, notwithstanding any redemption from sale, discharge of the mortgage indebtedness, satisfaction of any foreclosure judgment, or issuance of any certificate of sale or deed to any purchaser;
- (v) make all necessary or proper repairs, decorating, renewals, replacements, alterations, additions, estterments and improvements to the premises as Mortgagee may deem judicious; and
- (vi) insure and reinsure the premises against all risks incidental to Mortgagee's possession, operation and management thereof and receive all avails, rents, issues and profits therefrom.
- (e) Any avails, rents, issues and profits of the premises received by Mortgagee after having possession of the premises or pursuant to any assignment thereof to Mortgagee under the provisions of this Mortgage shall be applied in payment of or on account of the following, in such order as Mortgague (or in case of a receivership, as the court) may determine in its reasonable business judgment:

- (ii) to the payment of taxes, special assessments and water taxes now due or which may hereafter become due on the premises, or which may become a lien prior to the lien of this Mortgage;

(iii) to the payment of all reasonable repairs, decorating, renewals, replacements, alterations, additions, betterments and improvements of the premises, to place said property in such condition as will, in the reasonable judgment of Mortgagee or receiver, make it readily saleable or rentable; and

(iv) to the payment of any indebtedness secured hereby or any deficiency which may result from any foreclosure sale.

SEVENTEENTH: <u>Transfer or Property</u>: If all or any part of the premises is sold, transferred, conveyed, assigned or alienated (which shall include the execution of any form of installment agreement for deed) by Mortgagor without the Mortgagee's prior written consent, Mortgagee may, at Mortgagee's option, declare all the sums secured by this Mortgage to be immediately due and payable without notice.
