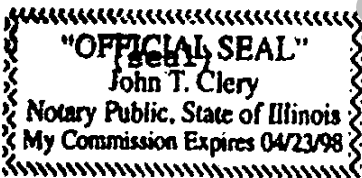

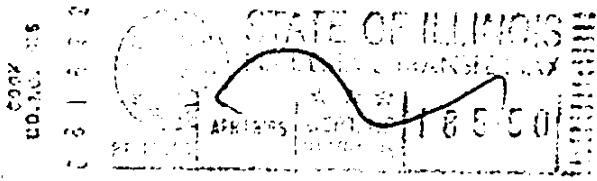

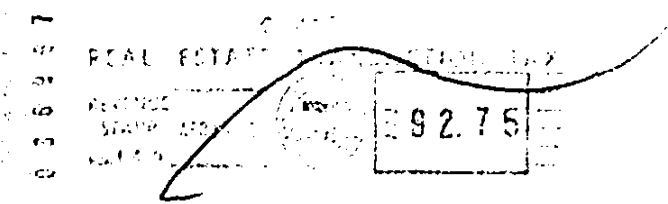

Scannable document - read the following rules
