to become due from the owner under said contract against said contractor and owner.

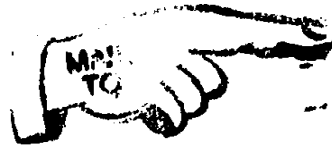

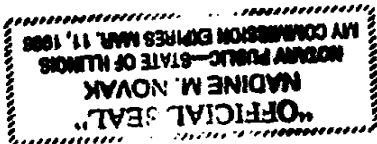
