

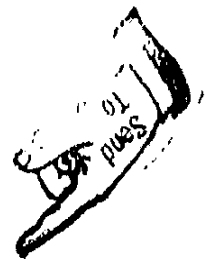
LEGAL DESCRIPTION RIDER
