THIS AGREEMENT, made and entered into this 17th day of April, 1995, by and between the VILLAGE OF ORLAND PARK, an Illinois Municipal Corporation, hereinafter called "VILLAGE" and BREMEN BANK AND TRUST (NOW KNOWN AS HERITAGE TRUST COMPANY), AS TRUSTE UNDER TRUST AGREEMENT DATED APRIL 3, 1979, AND KNOWN AS TRUST NUMBER 79-1432, hereinafter called "CWNER OF RECORD."
