That on June 9, 1993, said contractor made a subcontract with the claimant to perform the special coating, painting and wall covering work for and in said improvement, and that on February 1, 1995, the claimant completed thereunder all required by said contract to be performed.

That at the special instance and request of said contractor the claimant furnished extra and additional materials at and extra and additional labor on said premises of the value of \$19,330.50 and completed same on February 1, 1995.

That said contractor is entitled to credits on account thereof as follows: Twenty Four Thousand Eighty-nine and no/100 (\$24,098.00) Dollars leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of Twenty Three Thousand Two Hundred Forty-one and 50/100 (\$23,241.50) Dollars, for which, with interest the claimant claims a lien on said land and improvements on the moneys or other considerations due or to become due from the owner under said contract against said contractor and owner.



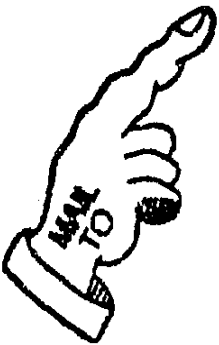
