CONSTRUCTION LOAN MORTGAGE AND SECURITY AGREEMENT

THIS CONSTRUCTION LOAN MORTGAGE AND SECURITY AGREEMENT dated as of February 1, 1995, from ORCHARD PARK LIMITED PARTNERSHIP, an Illinois limited partnership (the "Mortgagor"), to LASALLE NATIONAL BANK, a national banking association (the "Mortgagee");

WITNESSETH:

WATREAS, the Mortgagor has, concurrently herewith, executed and delivered to the Mortgagee its Construction Loan Mortgage Note (the "Note") bearing even date herewith in the principal sum of \$1,700,000, payable to the order of the Mortgagee, the terms of which are acre fully described in Section 2.1 hereof; and

WHEREAS, the Note evidences a construction loan being made by the Mortgages to the Mortgagor for the purpose of financing the construction on the real estate described in Exhibit A attached hereto of 10 rental townhome units in Phase I of the 80-unit Orchard Park Townhome Development in Chicago, Illinois, the foundations of up to 20 additional rental townhome units in Phase II of such townhome development, and certain predevelopment costs and land development costs related to such townhome development;

NOW, THEREFORE, THIS CONSTRUCTION LOAN MORTGAGE AND SECURITY AGREEMENT WITNESSETH THAT:

FOR GOOD AND VALUABLE CONSIDERATION, including the indebtedness hereby secured, the receipt and sufficiency of which are hereby acknowledged, the Mortgagor hereby grants, bargains, sells, conveys and mortgages to the Mortgagee and its successors and assigns forever, under and subject to the terms and conditions hereinafter set forth, all of the Mortgagor's right, title and interest in and to the real property located in the City of Chicago, County of Cook, State of Illinois, described in Exhibit A attached hereto and by this reference incorporated herein, including all improvements now and hereafter located thereon;

TOGETHER WITH all right, title and interest of the Mortgagor, now owned or hereafter acquired, in and to the following:

- (a) All rents, issues, profits, royalties and income with respect to the said real estate and improvements and other benefits derived therefrom, subject to the right, power and authority given to the Mortgagor to collect and apply same; and
- (b) All leases or subleases covering the said real estate and improvements or any portion thereof now or hereafter existing or entered into, including, but not limited to, the Leases (as defined in Article I hereof), including, without

limitation, all cash security deposits, advance rentals, and deposits or payments of similar nature, and any and all guarantees of the lessee's obligations under any of such leases and subleases; and

- (c) All privileges, reservations, allowances, hereditaments and appurtenances belonging or pertaining to the said real estate and improvements and all rights and estates in reversion or remainder and all other interests, estates or other claims, both in law and in equity, which the Mortgagor now has or may hereafter acquire in the said real estate and improvements; and
- (d) All easements, rights-of-way and rights used in connection with the said real estate and improvements or as a means of ingress and egress thereto, and all tenements, hereditaments and appurtenances thereof and thereto, and all water rights and shares of stock evidencing the same; and
- (e) Any land Tying within the right-of-way of any street, open or proposed, adjoining the said real estate and improvements, and any and all sidewalks, alleys and strips and gores of land adjacent to or used in connection with the said real estate and improvements; and
- (f) Any and all buildings and improvements now or hereafter erected on the said real estate, including, but not limited to, all the fixtures, attachments, appliances, equipment, machinery, and other articles attached to said buildings and improvements; and
- (g) All materials intended for construction, reconstruction, alteration and repairs of the said real estate and improvements, all of which materials shall be deemed to be included within the said real estate and improvements immediately upon the delivery thereof to the sall real estate; and
- (h) All fixtures attached to or contained in and used in connection with the said real estate and improvements, including, but not limited to, all machinery, motors, elevators, fittings, radiators, awnings, shades, screens, and all plumbing, heating, lighting, ventilating, refrigerating, incinerating, air-conditioning and sprinkler equipment and fixtures and appurtenances thereto; and all items of furniture, furnishings, equipment and personal property used or useful in the operation of the said real estate and improvements; and all N renewals, substitutions and replacements for any or all of the foregoing, and all proceeds therefrom, whether or not the same are or shall be attached to the said real estate and improvements in any manner; it being mutually agreed, intended and declared that all the aforesaid property placed by the

Mortgagor on and in the said real estate and improvements shall, so far as permitted by law, be deemed to form a part and parcel of the real estate and for the purpose of this Mortgage to be real estate and covered by this Mortgage; and as to any of the aforesaid property which does not so form a part and parcel of the real estate or does not constitute a "fixture" (as such term is defined in the Uniform Commercial Code of Illinois), this Mortgage is deemed to be a security agreement under the Uniform Commercial Code of Illinois for the purpose of creating hereby a security interest in such property, which the Mortgagor hereby grants to the Mortgagee as secured party;

- claims or demands, including claims or demands with respect to any proceeds of insurance related thereto, which the Mortgagor now has or may hereafter acquire, in the said real estate and improvements or personal property and any and all awards made for the taking by eminent domain, or by any proceeding or purchase in lieu thereof, of the whole or any part of the said real estate and improvements or personal property, including without limitation any awards resulting from a change of grade of streets and awards for severance damages;
- (j) All right, title and interest of the Mortgagor (but not its obligations) in, to and under the Leasehold Estate Lease (as defined in Article I hereof) as amended from time to time, and the leasehold estate created thereunder (except the last day of the original or any extended term of the Leasehold Estate Lease), and any extension thereof;
- (k) All right, title and interest of the Mortgagor (but not its obligations) in, to and under the Development Agreement (as defined in Article I hereof) as amended from time to time; and
- (1) All right, title and interest of the Mortgagor (but not its obligations) in, to and under the Master Kental Agreement (as defined in Article I hereof) as amendai from time to time;

the said real estate and improvements and the property and interests described in (a) through (1) above being collectively referred to herein as the "Premises;" and as to any portion of the Premises constituting property subject to the Uniform Commercial Code of Illinois, this Mortgage shall be deemed to be a security agreement under such Code for the purpose of creating hereby a security interest in such portion of the Premises, which the Mortgagor hereby grants to the Mortgagee as secured party.

TO HAVE AND TO HOLD the same unto the Mortgagee and its successors and assigns forever, for the purposes and uses herein set forth.

FOR THE PURPOSE OF SECURING the following (but not exceeding \$3,400,000 in the aggregate):

- (a) Payment of the indebtedness evidenced by the Note, and including the principal thereof and interest thereon and any and all modifications, extensions and renewals thereof, and performance of all obligations of the Mortgagor under the Note; and
- (a) Performance and observance by the Mortgagor of all of the terms, covenants and provisions of this Mortgage; and
- (c) Performance and observance by the parties thereto of all of the terms, covenants and provisions of the other Loan Documents (as defined in Article I hereof); and
- (d) Payment of all sums advanced by the Mortgagee to perform any of the tarms, covenants and provisions of this Mortgage or any of the other Loan Documents (as defined in Article I hereof), or otherwise advanced by the Mortgagee pursuant to the provisions hereof or any of such other documents to protect the property hereby mortgaged and pledged; and
- (e) Performance and observance of all of the terms, covenants and provisions of any other instrument given to evidence or further secure the payment and performance of any indebtedness hereby secured or any obligation secured hereby; and
- (f) Payment of any future or further advances which may be made by the Mortgagee at its sole option to and for the benefit of the Mortgagor, its successors, assigns and legal representatives.

PROVIDED, HOWEVER, that if the Mortgagor shall pay the principal and all interest as provided in the Note, and small pay all other sums herein provided for, or secured hereby, and shall well and truly keep and perform all of the covenants herein contained, then this Mortgage shall be released at the cost of the Mortgagor, otherwise to remain in full force and effect.

TO PROTECT THE SECURITY OF THIS CONSTRUCTION LOAN MORTGAGE AND SECURITY AGREEMENT, THE MORTGAGOR HEREBY COVENANTS AND AGREES AS FOLLOWS:

ARTICLE I

DEFINITIONS

Section 1.1. <u>Definitions</u>. The terms defined in this Section (except as otherwise expressly provided or unless the context otherwise requires) for all purposes of this Mortgage shall have the respective meanings specified in this Section.

"Assignment of Plans" means the Assignment of Plans, Permits and Contracts dated as of February 1, 1995, from the Mortgager to the Mortgagee.

"Assignment of Rents" means the Construction Loan Assignment of Rents and Leases dated as of February 1, 1995, from the Mortgagor to the Mortgagee.

"Authority" means Housing Authority of the City of Chicago, Illinois, an Illinois municipal corporation.

"Development Agreement" means the Development Agreement dated as of 'April (E) 1 . 1995, by and among the Authority, the Mortgagor and CMHDC.

"event of default" when used in reference to this Mortgage means an event of default specified in Section 4.1 hereof.

"CMHDC" means Chicago Metropolitan Housing Development Corporation, an Illinois not for profit corporation.

"General Partner" means Orchard Pack, L.L.C., an Illinois limited liability company.

"Guaranty" means the Construction Loan Casranty of Payment and Performance dated as of February 1, 1995, from CMHDC to the Mortgagee.

"Guaranty Security Agreement" means the Construction Loan Security Agreement (FAF Refunding Payments) dated as of February 1, 1995, from CMHDC to the Mortgagee.

"Hazardous Material" means any hazardous substance or any pollutant or contaminant defined as such in (or for purposes of) the Comprehensive Environmental Response, Compensation, and Liability Act, any so-called "Superfund" or "Superlien" law, The Toxic Substances Control Act, or any other federal, state or local statute, law, ordinance, code, rule, regulation, order or decree regulating, relating to or imposing liability or standards of conduct concerning any hazardous, toxic or dangerous waste, substance or material, as now or at any time hereafter in effect; asbestos or any substance or compound containing asbestos;

polychlorinated biphenyls or any substance or compound containing any polychlorinated biphenyl; petroleum and petroleum products; pesticides; and any other hazardous, toxic or dangerous waste, substance or material.

"Impositions" means Impositions as defined in Section 2.6(a) hereof.

"Improvements" means 10 rental townhome units in Phase I of the 80-unit Orchard Park Townhome Development to be constructed on the Premises, and the foundations of up to 30 additional rental townhome units in Phase II of such townhome development.

"Indemnity Agreement" means the Construction Loan Indemnity Agreement dated as of February 1, 1995, from the Mortgagor and the General Partner to the Mortgagee.

"Leasehold Estate Lease" means the Ground Lease Agreement dated as of April 1995, by and between the Authority, as lessor, and the Mortgacor, as lessee, a memorandum of which was recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on April 27, 1995, as Document No.

"Leases" means the lease or leases described in Exhibit B attached hereto.

"Loan Agreement" means the Construction Loan Agreement dated as of February 1, 1995, by and between the Mortgagor and the Mortgagee.

"Loan Documents" means the Loan Agriculent, the Note, this Mortgage, the Assignment of Rents, the Assignment of Plans, the Indemnity Agreement, the Guaranty, the Guaranty Security Agreement, and all other documents and instruments at any time evidencing and securing the indebtedness secured by this Mortgage.

"Master Rental Agreement" means the Master Rental Assistance and Support Services Agreement to be entered in by the Authority and the Mortgagor.

"Mortgage" means this Construction Loan Mortgage and Security Agreement dated as of February 1, 1995, from the Mortgagor to the Mortgagee.

"Mortgagee" means LaSalle National Bank, a national banking association.

"Mortgagor" means Orchard Park Limited Partnership, an Illinois limited partnership.

mage Note of the

"Note" means the Construction Loan Mortgage Note of the Mortgagor dated February 1, 1995, in the principal amount of \$1,700,000 made payable to the order of the Mortgages.

"Permitted Encumbrances" means Permitted Encumbrances as defined in the Loan Agreement.

"Premises" means the leasehold estate described in Exhibit A attached hereto and all improvements now and hereafter located on the real estate described in Exhibit A, and all other property, rights and interests described in the foregoing granting clauses of this Mortgage.

ARTICLE II

CO"ENANTS AND AGREEMENTS OF MORTGAGOR

Section 2.1. Payment of Indebtedness. The Mortgagor covenants and agrees that it will pay when due the principal of and interest on the indebtedness hereby secured evidenced by the Note, all other sums which may become due pursuant thereto or hereto, and all other indeptedness hereby secured as described in the foregoing granting clauses of this Mortgage, including, but not limited to, all charges, feas and all other sums to be paid by the Mortgagor as provided in the Loan Documents, and that it will duly and punctually perform, observe and comply with all of the terms, provisions and conditions herein and in the other Loan Documents provided to be performed and observed by the Mortgagor. The Note, which is hereby incorporated into this Mortgage by reference with the same effect as if set forth in full herein, is in the principal amount of \$1,700,000 and bears interest at a variable rate of 1% per annum in addition to the Mortgagee's Prime Rate (as defined below) from time to time in effect while the Note is outstanding. For such purposes, the term "Prime Rate" shall mean, at any time, and from time to time, that rate of interest then most recently announced by the Morigagee as its prime rate of interest. Changes in the rate of interest on the Note resulting from a change in the Prime Rate shall take effect on the date of change in the Prime Rate. The Mortgages aball not be obligated to give notice of any change in the Prime Rate. Interest is payable on the Note in arrears on the first day of each month commencing with the month following the month in which the first disbursement of principal occurs. All of the unpaid principal of and accrued interest on the Note shall be due and payable on September 30, 1995.

Section 2.2. Escrow Deposits. Except to the extent deposits are made by the Mortgagor for such purposes under the Leasehold Estate Lease, or to the extent that a reserve for taxes and/or insurance premiums has been created and exists under the

Loan Agreement, if requested by the Mortgagee, in order to provide moneys for the payment of the Impositions on the Premises required to be paid by the Mortgagor pursuant to Section 2.6 hereof and the premiums on the insurance required to be carried by the Mortgagor pursuant to Section 2.4 hereof, the Mortgagor shall pay to the Mortgagee with each monthly interest payment on the Note such amount as the Mortgagee shall estimate will be required to accumulate, by the date 30 days prior to the due date of the next annual installment of such Impositions and insurance premiums, through substantially equal monthly payments by the Mortgagor to the Mortgagee, amounts sufficient to pay such next annual (mpositions and insurance premiums. All such payments shall be held by the Mortgages in escrow, and the Mortgages shall not be obligated to pay interest thereon. Amounts held in such escrow shall be made available by the Mortgagee to the Mortgagor for the payment of the Impositions and insurance premiums on the Premises when dus or may be applied thereto by the Mortgagee if it in its sole discretion so elects. The Mortgagee may at any time and from time co time waive the requirement for the escrow deposits provided for in this Section. In the event of any such waiver, the Mortgagee may thereafter in its sole discretion elect to require that the Mortgagor commence making such escrow deposits by giving the Mortgagor not less than 10 days' written notice of such election. No such waiver shall impair the right of the Mortgagee thereafter to require that such escrow deposits be made.

Section 2.3. Completion, Maintenance, Repair, Alterations. The Mortgagor covenants end agrees that it will:

- (a) keep the Premises in good condition and repair;
- (b) not remove, demolish or substantially alter (except such alterations as may be required by laws, ordinances or governmental regulations) any of the improvements which are a part of the Premises;
- (c) complete promptly and in a good and workmarlike manner the construction of the Improvements as contemplated by the Loan Agreement, or any other improvements which may be constructed on or at the Premises;
- (d) promptly repair and restore any portion of the Premises which may become damaged or be destroyed so as to be of at least equal value and of substantially the same character as prior to such damage or destruction;
- (e) subject to Section 2.13(b) hereof, pay when due all claims for labor performed and materials furnished to and for the Premises;

- (f) comply with all laws, ordinances, regulations, covenants, conditions and restrictions now or hereafter affecting the Premises or any part thereof or requiring any alterations or improvements;
- (g) not commit or permit any waste or deterioration of the Premises or any portion thereof;
- (h) keep and maintain the Premises and abutting grounds, sidewalks, roads, parking and landscape areas in good and neat order and repair and free of nuisance;
- (i) not commit, suffer or permit any act to be done in or upon the Premises in violation of any law, ordinance or regulation.
- (j) not initiate or acquiesce in any zoning change or reclassification of the Premises; and
- (k) subject to Section 2.13(b) hereof, keep the Premises free and clear of all liens and encumbrances of every sort.
- Section 2.4. Required Insurance. The Mortgagor shall at all times provide, maintain sod keep in force the following policies of insurance:
 - (a) Insurance against loss or damage to the Premises by fire and any of the risks covered by insurance of the type now known as "fire and extended coverage", in an amount not less than the full replacement cost thereof (exclusive of the cost of excavations, foundations and footings below the lowest basement floor), and with not more than \$10,000 deductible from the loss payable for any casualty.
 - (b) Comprehensive public liability insurance, including coverage for elevators and escalators, if any, on the Premises, on an occurrence basis against claims for personal injury, including without limitation bodily injury, death or property damage occurring on, in or about the Premises and the adjoining streets, sidewalks and passageways, such insurance to afford immediate minimum protection to a limit of not less than \$1,000,000 for one person and \$3,000,000 per occurrence for personal injury or death and \$500,000 per occurrence for damage to property.
 - (c) Workers' compensation insurance in accordance with the requirements of Illinois law.
 - (d) During the course of any construction or repair at the Premises, builder's risk insurance against all risks of physical loss, on a completed value basis, including collapse

and transit coverage, with a deductible not to exceed \$10,000, in nonreporting form, covering the total value of work performed and equipment, supplies and materials furnished, and containing the "permission to occupy upon completion of work" endorsement.

- (e) Boiler and machinery insurance covering pressure vessels, air tanks, boilers, machinery, pressure piping, heating, air conditioning and elevator equipment and escalator equipment located on the Premises, and insurance against loss of occupancy or use arising from any breakdown therein, all in such amounts as are satisfactory to the Mortgagee.
- (f) Business interruption, use and occupancy or rent loss insurance on the Premises covering loss of the use of the Premises covered by the policies described in (a) and (a) above, for a period of not less than one year in such amount as the Mortgagee may require.
- (g) If the Premises are located in an area that has been identified by the United States Department of Housing and Urban Development as an area having special flood hazards and if the sale of flood insurance has been made available under the National Flood Insurance but of 1968, flood insurance in an amount at least equal to the replacement cost of the Premises or to the maximum limit of coverage made available with respect to the particular type of property under the National Flood Insurance Act of 1968, whichever is less.
- (h) Such other insurance, and in such amounts, as may from time to time be required by the Morcgagee against the same or other hazards.

All policies of insurance required by terms of this Mortgage shall contain an endorsement or agreement by the insurer that any loss shall be payable in accordance with the terms of such policy notwithstanding any act or negligence of the Mortgagor which might otherwise result in forfeiture of said insurance and the further agreement of the insurer waiving all rights of sat-off, counterclaim or deductions against the Mortgagor, and shall provide that the amount payable for any loss shall not be reduced by reason of co-insurance.

Section 2.5. Delivery of Policies; Payment of Premiums. All policies of insurance required by the terms of this Mortgage shall be issued by companies and in amounts in each company satisfactory to the Mortgagee. All policies of insurance shall be maintained for and name the Mortgagor and the Mortgagee as insureds, as their respective interests may appear, and the policies required by paragraphs (a), (d), (e), (f) and (g) of Section 2.4 hereof shall have attached thereto a mortgagee's loss

payable endorsement for the benefit of the Mortgagee in form satisfactory to the Mortgagee. The Mortgagor shall furnish the Mortgagee with certificates of all required policies of insurance. At least 10 days prior to the expiration of each such policy, the Mortgagor shall furnish the Mortgagee with evidence satisfactory to the Mortgagee of the payment of the premium and the reissuance of a policy continuing insurance in force as required by this Mortgage. Each policy of insurance required by this Mortgage shall contain a provision that such policy will not be cancelled or materially amended, including any reduction in the scope or limits of coverage, without at least 30 days' prior written notice to the Mortgagee. Each policy of insurance required by this Mortgage shall also comply with the requirements of the Leasehold Estate Lease.

Section 2.6. Taxes and Impositions.

- (a) The Mortgagor agrees to pay or cause to be paid, at least 10 days prior to delinquency, all real property taxes and assessments, general and special, and all other taxes and assessments of any kind or nature whatsoever, including without limitation any non-governmental levies or assessments such as maintenance charges, owner association dues or charges or fees, levies or charges resulting from covenants, conditions and restrictions affecting the Premises, which are assessed or imposed upon the Premises, or Necome due and payable, and which create, may create or appear to create a lien upon the Premises, or any part thereof (all of which taxes, assessments and other governmental charges and non-governmental charges of the above-described or like nature are here nafter referred to as "Impositions"); provided however, that if, by law, any such Imposition is payable, or at the option of the taxpayer may be paid, in installments, the Mortgagor may pay the same together with any accrued interest on the unpaid balance of such Imposition in installments as the same become due and before any fine, penalty, interest or cost may be added thereto for the nonpayment of any such installment and interest.
- (b) The Mortgagor shall furnish to the Mortgages within 30 days after the date upon which any Imposition is due and payable by the Mortgagor, official receipts of the appropriate taxing authority, or other proof satisfactory to the Mortgagee, evidencing the payment thereof.
- (c) The Mortgagor shall have the right before any delinquency occurs to contest or object to the amount or validity of any Imposition by appropriate legal proceedings properly instituted and prosecuted in such manner as shall stay the collection of the contested Impositions and prevent the sale or forfeiture of the Premises to collect the same; provided that no such contest or objection shall be deemed or construed in any way

as relieving, modifying or extending the Mortgagor's covenants to pay any such Imposition at the time and in the manner provided in this Section unless the Mortgagor has given prior written notice to the Mortgagee of the Mortgagor's intent to so contest or object to an Imposition, and unless, at the Mortgagee's sole option, (i) the Mortgagor shall demonstrate to the Mortgagee that legal proceedings instituted by the Mortgagor contesting or objecting to such impositions shall conclusively operate to prevent the sale or forfeiture of the Premises, or any part thereof, to satisfy such Imposition prior to final determination of such proceedings; and/or (ii) the Mortgagor shall furnish a good and sufficient bond or surety as requested by the Mortgagee, or a good and sufficient undertaking as may be required or permitted by law to accomplish a stay of any such sale or forfeiture of the Premises during the pendency of such contest, adequate fully to pay all such contested Impositions and all interest and paralties upon the adverse determination of such contest.

Section 2.7. Itilities. The Mortgagor shall pay or cause to be paid when due all itility charges which are incurred by the Mortgagor or others for the benefit of or service to the Premises or which may become a charge or lien against the Premises for gas, electricity, water or aswer services furnished to the Premises and all other assessments or charges of a similar nature, whether public or private, affecting the Premises or any portion thereof, whether or not such assessments or charges are liens thereon.

Section 2.8. Actions by Mortgage to Preserve Premises. Should the Mortgagor fail to make any payment or to do any act as and in the manner provided herein or in any of the other Loan Documents, the Mortgagee in its own discretion, without obligation so to do and without releasing the Mortgagor from any obligation, may make or do the same in such manuer and to such extent as it may deem necessary to protect the security hereof. In connection therewith (without limiting its general powers), the Mortgagee shall have and is hereby given the right but not the obligation, (i) to enter upon and take possession or the Premises; (ii) to make additions, alterations, repairs and improvements to the Premises which it may consider necessary and proper to keep the Premises in good condition and repair; (iii) to appear and participate in any action or proceeding affecting or which may affect the Premises, the security hereof or the rights or powers of the Mortgagee; (iv) to pay any Impositions (as defined in Section 2.6 hereof) asserted against the Premises and to do so according to any bill, statement or estimate procured from the appropriate office without inquiry into the accuracy of the bill, statement or estimate or into the validity of any Imposition; (v) to pay, purchase, contest or compromise any encumbrance, claim, charge, lien or debt which in the

judgment of the Mortgagee may affect or appears to affect the Premises or the security of this Mortgage or which may be prior or superior hereto; (vi) to pay any rents, additional rents, and other amounts payable under or in connection with the Leasehold Estate Lease; (vii) to complete the construction of the Improvements and to take such actions in connection therewith as are provided for in the Loan Agreement; and (viii) in exercising such powers, to pay necessary expenses, including employment of and payment of compensation to counsel or other necessary or desirable consultants, contractors, agents and other employees. The Mortgagor irrevocably appoints the Mortgagee its true and lawful attorney in fact, at the Mortgagee's election, to do and cause to be done all or any of the foregoing in the event the Mortgagee shall be entitled to take any or all of the action provided for in this Section. The Mortgagor shall immediately, upon demand therefor by the Mortgagee, pay all costs and expenses incurred by the Mortgagee in connection with the exercise by the Mortgagee of the foregoing rights, including without limitation, costs of evidence of title, court costs, appraisals, surveys and attorneys' fees, all of which shall constitute so much additional indebtedness secured by his Mortgage immediately due and payable, with interest thereon at a rate two percent (2%) above the then prevailing interest rate on the Note.

Section 2.9. Damage and Destruction.

- (a) The Mortgagor shall give the Mortgagee prompt notice of any damage to or destruction of any portion or all of the Premises, and the provisions contained in the following paragraphs of this Section shall apply in the event of any such damage or destruction.
- (b) Subject to the rights of the lessor and lessee under the Leasehold Estate Lease, in the case of less covered by policies of insurance, the Mortgagee is hereby authorized at its option either (i) to settle and adjust any claim under such policies without the consent of the Mortgagor, or (ii) to allow the Mortgagor to agree with the insurance company or companies on the amount to be paid upon the loss; and in any case the Mortgagee shall, and is hereby authorized to, collect and receipt for any such insurance proceeds; and the reasonable expension incurred by the Mortgagee in the adjustment and collection of insurance proceeds shall be so much additional indebtedness secured by this Mortgage, and shall be reimbursed to the Mortgagee upon demand.
- (c) Subject to the rights of the lessor and lessee under the Leasehold Estate Lease, in the event of any insured damage to or destruction of the Premises or any part thereof the proceeds of insurance payable as a result of such loss shall be applied upon the indebtedness secured by this Mortgage or applied to the

repair and restoration of the Premises, as the Mortgagee in its sole discretion shall elect.

(d) In the event that the Mortgagee shall elect that proceeds of insurance are to be applied to the repair and restoration of the Premises, the Mortgagor hereby covenants promptly to repair and restore the same. In such event such proceeds shall be made available, from time to time, to pay or reimburse the costs of such repair and restoration in the manner and on the terms provided in the Loan Agreement for disbursements of construction loan proceeds.

Section 2.10. Eminent Domain.

- (a) Should the Premises or any part thereof or interest therein be taken or damaged by reason of any public improvement or condemnation proceeding, or in any other manner, or should the Mortgagor receivs any notice or other information regarding any such proceeding, the Mortgagor shall give prompt written notice thereof to the Mortgagee, and the provisions contained in the following paragraphs or this Section shall apply.
- (b) Subject to the rights of the lessor and lessee under the Leasehold Estate Lease
 - (i) The Mortgagee shall be entitled to all compensation, awards and other payments or relief therefor (except awards made to tenants of the Premises), and shall be entitled at its option to commence, appear in and prosecute in its own name any action or proceedings;
 - (ii) The Mortgagee shall also be entitled to make any compromise or settlement in connection with such taking or damage; and
 - (iii) All proceeds of compensation, awards, damages, rights of action and proceeds awarded to the Mortgagor are hereby assigned to the Mortgagee and the Mortgager agrees to execute such further assignments of such proceeds as the Mortgagee may require.
- (c) Subject to the rights of the lessor and lessee under the Leasehold Estate Lease, in the event that any portion of the Premises are taken or damaged as aforesaid, all such proceeds shall be applied upon the indebtedness secured by this Mortgage or applied to the repair and restoration of the Premises, as the Mortgagee in its sole discretion shall elect.
- (d) In the event that the Mortgagee shall elect that such proceeds are to be applied to the repair and restoration of the Premises, the Mortgagor hereby covenants promptly to repair and

restore the same. In such event such proceeds shall be made available, from time to time, to pay or reimburse the costs of such repair and restoration in the manner and on the terms provided in the Loan Agreement for disbursements of construction loan proceeds.

Section 2.11. Inspection of Premises. The Mortgagee, or its agents, representatives or workmen, are authorized to enter at any reasonable time, with such prior notice as shall be reasonable under the circumstances, upon or in any part of the Premises for the purpose of inspecting the same and for the purpose of performing any of the acts it is authorized to perform under the terms of this Mortgage or any of the other Loan Documents.

Section 2.12. Inspection of Books and Records; Financial Statements.


- (a) The Mortgagor shall keep and maintain full and correct records showing in detail the income and expenses of the Premises and shall make such books and records and all supporting vouchers and data available for examination by the Mortgagee and its agents at any time and from time to time on request at the offices of the Mortgagee, or at such other location as may be mutually agreed upon.
- (b) The Mortgagor shall furnish to the Mortgagee (i) copies of all income tax returns of the Mortgagor promptly after same are prepared and filed; and (ii) within 30 days after the end of the first six months of each of the Mortgagor's fiscal years, a semi-annual financial statement of the Mortgagor, and within 30 days after the end of each of the Mortgagor's fiscal years, an annual financial statement of the Mortgagor's fiscal years, an annual financial statement of the Mortgagor, in each case consisting of at least a balance sheet as at the end of such six-month or one-year period and an income statement and cash flow statement for such six-month or one-year period, and prepared in reasonable detail and in a form acceptable to the Mortgagee and signed and certified by an authorized representative of the Mortgagor.

Section 2.13. Title, Liens and Conveyances.

- (a) The Mortgagor represents that it holds a valid leasehold estate in the Premises under the Leasehold Estate Lease, subject only to the Permitted Encumbrances.
- (b) Except for Permitted Encumbrances, the Mortgagor shall not, without the prior written consent of the Mortgagee, which may be given or withheld in its sole discretion, create, suffer or permit to be created or filed against the Premises, or any part thereof or interest therein, any mortgage lien or other

lien, charge or encumbrance, either superior or inferior to the lien of this Mortgage. The Mortgagor shall have the right to contest in good faith the validity of any such lien, charge or encumbrance, provided the Mortgagor shall first deposit with the Mortgagee a bond or other security satisfactory to the Mortgagee in such amounts or form as the Mortgagee shall require; provided further that the Mortgagor shall thereafter diligently proceed to cause such lien, encumbrance or charge to be removed and discharged. If the Mortgagor shall fail to discharge any such lien, encumbrance or charge, then, in addition to any other right or remedy of the Mortgagee, the Mortgagee may, but shall not be obligated to, discharge the same, either by paying the amount claimed to be due, or by procuring the discharge of such lien by depositing in court a bond for the amount claimed or otherwise giving security for such claim, or in such manner as is or may be prescribed by law and any amounts expended by the Mortgagee in so doing shall be so much additional indebtedness secured by this Mortgage. Except for Permitted Encumbrances and liens, charges and encumbrances being contested as provided above, in the event the Mortgagor shall suffer or permit any superior or junior lien to be attached to the ?remises, the Mortgagee, at its option, shall have the unqualified right to accelerate the maturity of the Note causing the full principal balance and accrued interest on the Note to become immediately due and payable without notice to the Mortgagor.

- (c) In the event title to the Premises is now or hereafter becomes vested in a trustie, any prohibition or restriction contained herein upon the treation of any lien against the Premises shall also be construed as a similar prohibition or limitation against the creation of any lien or security interest upon the beneficial interest under such trust.
- (d) In the event that the Mortgagor shall sell, transfer, convey or assign the title to all or any portion of the Premises, whether by operation of law, voluntarily, or otherwise, or the Mortgagor shall contract to do any of the foregoing (provided that the option of the Mortgagor provided for in Section 6.4 of the Development Agreement shall not be deemed to be a "contract" within the meaning of this paragraph unless and until such option is exercised), the Mortgagee, at its option, shall have the unqualified right to accelerate the maturity of the Note causing the full principal balance and accrued interest on the Note to become immediately due and payable without notice to the Mortgagor.
- (e) Any waiver by the Mortgagee of the provisions of this Section shall not be deemed to be a waiver of the right of the Mortgagee to insist upon strict compliance with the provisions of this Section in the future.

- (f) The Mortgagor shall at all times duly perform and observe all of the terms, provisions, conditions and agreements on its part to be performed and observed under the Leasehold Estate Lease, and shall not suffer or permit any default or event of default on the part of the Mortgagor to exist thereunder, and shall not agree or consent to, or suffer or permit, any termination, surrender, modification or amendment thereof.
- (g) The Mortgagor shall at all times duly perform and observe all of the terms, provisions, conditions and agreements on its part to be performed and observed under the Development Agreement, and shall not suffer or permit any default or event of default on the part of the Mortgagor to exist thereunder, and shall not agree or consent to, or suffer or permit, any modification or amendment thereof, or any termination thereof other than as permitted under Section 6.1(x) of the Loan Agreement.
- (h) The Mortgagor shall at all times duly perform and observe all of the tame, provisions, conditions and agreements on its part to be performed and observed under the Master Rental Agreement, and shall not suffer or permit any default or event of default on the part of the Mortgagor to exist thereunder, and shall not agree or consent to, or suffer or permit, any termination, modification or amendment thereof.

Section 2.14. Taxes Affecting Mortgage.


- (a) If at any time any federal, state or municipal law shall require any documentary stamps or other tax hereon or on the Note, or shall require payment of any tax upon the indebtedness secured hereby, then the said indebtedness and the accrued interest thereon shall be and become due and payable at the election of the Mortgagee upon 30 days' necice to the Mortgagor; provided, however, said election shall be unavailing and this Mortgage and the Note shall be and remain in effect, if the Mortgagor lawfully may pay for such stamps or such tax including interest and penalties thereon to or on behalf of the Mortgagee and the Mortgagor does in fact pay, when payable, for all such stamps or such tax, as the case may be, including interest and penalties thereon.
- (b) In the event of the enactment after the date of this Mortgage of any law of the state in which the Premises are located deducting from the value of the Premises for the purpose of taxation any lien thereon, or imposing upon the Mortgages the payment of the whole or any part of the taxes or assessments or charges or liens herein required to be paid by the Mortgagor, or changing in any way the laws relating to the taxation of mortgages or debts secured by mortgages or the Mortgagee's interest in the Premises, or the manner of collection of taxes,



so as to affect this Mortgage or the debt secured hereby or the holder hereof, then, and in any such event, the Mortgagor, upon demand by the Mortgagee, shall pay such taxes or assessments, or reimburse the Mortgagee therefor; provided, however, that if, in the opinion of counsel for the Mortgagee, (i) it might be unlawful to require Mortgagor to make such payment or (ii) the making of such payment might result in the imposition of interest beyond the maximum amount permitted by law, then, and in such event, all of the indebtedness secured hereby shall become due and payable within 30 days from the giving of such notice. Notwithstanding the foregoing, it is understood and agreed that the Mortgagor is not obligated to pay any portion of Mortgagee's federal or state income tax.

Section 2.15. Environmental Matters.

- (a) The Mortgagor hereby represents and warrants to the Mortgagee that meither the Mortgagor nor any of its affiliates or subsidiaries, nor, to the best of the Mortgagor's knowledge, any other person or entity, has ever caused or permitted any Hazardous Material to be placed, held, located or disposed of on, under or at (i) the Promises or any part thereof, or (ii) any other real property in which the Mortgagor or any of its affiliates or subsidiaries bolds any estate or interest whatsoever (including, without limitation, any property owned by a land trust the beneficial interest in which is owned, in whole or in part, by the Mortgagor or any of its affiliates or subsidiaries), and that none of the property described above has ever been used by the Mortgagor or eny of its affiliates or subsidiaries, or, to the best of the Mortgagor's knowledge, by any other person or entity, as a treatment, storage or disposal site (whether permanent or temporary) for any Hazardous Material, and that there are no underground storage tanks located on the Premises.
- (b) Without limitation on any other provision hereof, the Mortgagor hereby agrees to indemnify and hold the Mortgagee harmless from and against any and all losses, liabilities, damages, injuries, costs, expenses and claims of any kina whatsoever (including, without limitation, any losses, liabilities, damages, injuries, costs, expenses or claims asserted or arising under any of the following (collectively, "Environmental Laws"): the Comprehensive Environmental Response, Compensation, and Liability Act, any so-called "Superfund" or "Superlien" law, or any other federal, state or local statute, law, ordinance, code, rule, regulation, order or decree, now or hereafter in force, regulating, relating to, or imposing liability or standards of conduct concerning any Hazardous Material) paid, incurred, suffered by or asserted against the Mortgagee as a direct or indirect result of any of the following, regardless of whether or not caused by, or within



the control of, the Mortgagor: (i) the presence of any Hazardous Material on or under, or the escape, seepage, leakage, spillage, discharge, emission, discharging or release of any Hazardous Material from (A) the Premises or any part thereof, or (B) any other real property in which the Mortgagor or any of its affiliates or subsidiaries holds any estate or interest whatsoever (including, without limitation, any property owned by a land trust the beneficial interest in which is owned, in whole or in part, by the Mortgagor or any of its affiliates or subsidiaries), or (ii) any liens against the Premises permitted or imposed by any Environmental Laws, or any actual or asserted liability or obligations of the Mortgagor or any of its affiliates or subsidiaries under any Environmental Laws, or (iii) any actual or asserted liability or obligations of the Mortgagee or any of the affiliates or subsidiaries under any Environmental Law relating so the Premises.

- (c) If any of the provisions of the Illinois Responsible Property Transfer Act of 1988 ("IRPTA") are now or hereafter become applicable to the Premises, the Mortgagor shall comply with such provisions. Without limitation on the generality of the foregoing, (i) if the delivery of a disclosure document is now or hereafter required by IRPTA, the Mortgagor shall cause the delivery of such disclosure document to be made to all parties entitled to receive same within the time period required by IRPTA; and (ii) the Mortgagor shall cause any such disclosure document to be recorded with the Recorder of Deeds of the county in which the Premises are located and filled with the Illinois Environmental Protection Agency, all within the time periods required by IRPTA. The Mortgagor shall promptly deliver to the Mortgagee evidence of such recording and filing of such disclosure document.
- (d) The representations, covenants, indemnities and obligations provided for in this Section 2.15 shall survive the payment, performance, satisfaction, discharge, cardellation, termination, release and foreclosure of this Mortgage; provided, however, that such representations, warranties, covenance, indemnities and obligations shall not apply with respect to Hazardous Materials which are first placed on the Premises on or after the date on which the Mortgagee or any other party obtains title to and possession of the Premises pursuant to an exercise by the Mortgagee of its remedies under this Mortgage or any of the other Loan Documents or as a result of a conveyance of title to the Premises by the Mortgagor to the Mortgagee or such other party in lieu of such exercise of remedies.

Section 2.16. Concerning the Leasehold Estate Lease.

(a) This Mortgage is subject to all the agreements, terms, covenants and conditions of the Leasehold Estate Lease.



- (b) The Mortgagor hereby represents and warrants to the Mortgagee as follows:
 - (i) The Leasehold Estate Lease is in full force and effect and has not been modified or amended.
 - (ii) All rents (including additional rents and other charges) required to be paid under the Leasehold Estate Lease have been paid to the extent they were payable prior to the date hereof.
 - (iii) There is no existing default under the provisions of the Leasehold Estate Lease or in the performance of any of the terms, covenants, conditions or warranties thereof on the part of the Mortgagor to be observed and performed.
- (c) The Mortgagor shall defend the leasehold estate created under the Leasehold Estate Lease for the entire remainder of the term set forth therein, against all persons claiming the same or any part thereof.
- (d) The Mortgagor shall pay or cause to be paid all rents, additional rents, taxes, assessments, water rates, sewer rents and other charges and impositions mentioned in and made payable by the Leasehold Estate Lease, when and as often as the same shall become due and payable, and shall cause the lessor under the Leasehold Estate Lease to pay any portion of said taxes, assessments, rates, harges and impositions to be borne by the lessor that might become liens on the Premises or its leasehold estate when due, and the Mortgagor shall in every case take, or cause to be taken, a proper receipt for any such item so paid and shall within 10 days after written request of the Mortgagee deliver, or cause to be delivered, to the Mortgagee the original receipts for any such payments.
- (e) Subject to any applicable grace periods and cure rights contained in the Leasehold Estate Lease, the Mortgagor shall at all times promptly and faithfully keep and perform, or cause to be kept and performed, all the covenants and conditions contained in the Leasehold Estate passe by the Mortgagor to be kept and performed and in all respects conform to and comply with the terms and conditions of the Leasehold Estate Lease, and the Mortgagor shall not do or permit anything which will impair or tend to impair the security of this Mortgage or will be grounds for declaring a forfeiture of the Leasehold Estate Lease.
- (f) The Mortgagor shall not modify, and, extend or in any way alter the terms of the Leasehold Estate Lease or cancel or surrender the Leasehold Estate Lease, or waiva. execute, condone or in any way release or discharge the lessor thereunder of or from the obligations, covenants, conditions and agreements



by said lessor to be done and performed; and the Mortgagor does by this Mortgage expressly release, relinquish and surrender to the Mortgagee all of its right, power and authority to cancel, surrender, amend, modify or alter in any way the terms and provisions of the Leasehold Estate Lease

- (g) The Mortgagor shall give the Mortgagee immediate notice of the receipt by it of any notice of default from the lessor under the Leasehold Estate Lease, and the Mortgagor shall furnish to the Mortgagee immediately any and all information which it may request concerning the performance by the Mortgagor of the covenants of the Leasehold Estate Lease, and shall permit the Mortgagee or its representative at all reasonable times to make investigation or examination concerning the performance by the Mortgagor of the covenants of the Leasehold Estate Lease. The Mortgagor shall also deposit with the Mortgagee an exact copy of any notice, communication, plan, specification or other instrument or Jecument received or given by it in any way relating to or affecting the Leasehold Estate Lease which may concern or affect the estate of the lessor or the lessee in or under the Leasehold Latate Lease or in the premises thereby demised.
- (h) In the event of any failure by the Mortgagor to perform any covenant on the cart of lessee to be observed and performed under the Leasehold Estate Lease, the performance by the Mortgagee on behalf of the Mortgagor of the Leasehold Estate Lease covenant (as provided in Section 2.8 hereof) shall not remove or waive, as between the Mortgagor and the Mortgagee, the corresponding event of default under the terms hereof.
- (i) To the extent permitted by law, the price payable by the Mortgagor, or by any other party so entitled, in the exercise of the right of redemption, if any, from sale under any order or decree of foreclosure of this Mortgage shall include all rents paid and other sums advanced by the Mortgagee, on behalf of the Mortgagor, as lessee under the Leasehold Estate Lesse.
- (j) So long as any of the indebtedness secured ry this Mortgage shall remain unpaid, unless the Mortgagee shall otherwise in writing consent, the fee title and the leasehold estate in the Premises shall not merge but shall always be kept separate and distinct, notwithstanding the union of said estates either in the lessor or in the lessee, or in a third-party, by purchase or otherwise; and the Mortgagor covenants and agrees that, in case it shall acquire the fee title, or any other estate, title or interest in the premises covered by the Leasehold Estate Lease, this Mortgage shall attach to and be a first lien upon such other estate so acquired and such other estate so acquired by the Mortgagor shall be considered as mortgaged, assigned or conveyed to the Mortgagee and the lien



hereof spread to cover such estate with the same force and effect as though specifically herein mortgaged, assigned or conveyed and spread. The provisions of this paragraph shall not apply in the event the holder of the Note acquires the fee of the mortgaged premises except if the Mortgagee shall so elect.

Section 2.17. Appraisals. It shall be a condition to the first advance of the proceeds of the Note that the Mortgagee shall have obtained an appraisal of the Premises and the Improvements in a form, and showing an appraised value, acceptable to the Mortgagee in its sole discretion. The Mortgages shall have the right at any time and from time to time to obtain an appraisal of the Premises and the Improvements. cost of all such appraisals shall be paid by the Mortgagor. Mortgagor ecknowledges that the Mortgagee shall have the right at any time and from time to time to obtain an appraisal of the Premises and the Improvements, and the cost of each such appraisal shall be paid by the Mortgagor; provided, however, that the Mortgagor snall not be obligated to pay for the cost of more than one appraisal creained by the Mortgagee after the date of the first disbursement of the proceeds of the Note and prior to the original maturity date of the Note, unless the Mortgagee determines that additional appraisals during such period are required because of probable changes in the value of the Premises.

Section 2.18. Estoppel Latters. The Mortgagor shall furnish from time to time within 15 days after the Mortgagee's request, a written statement, duly acmowledged, of the amount due upon this Mortgage and whether any alleged offsets or defenses exist against the indebtedness secured by this Mortgage.

ARTICLE III

LEASES; DECLARATION OF SUBORDINATION TO LEASES

Section 3.1. Leases. The Mortgagor agrees that it will at all times duly perform and observe all of the terms, provisions, conditions and agreements on its part to be performed and observed under any and all leases of the Premises, including, but not limited to, the Leases, or any portion thereof, and shall not suffer or permit any default or event of default on the part of the lessor to exist thereunder. Nothing herein contained shall be deemed to obligate the Mortgagee to perform or discharge any obligation, duty or liability of the lessor under any lease of the Premises, and the Mortgagor shall and does hereby indemnify and hold the Mortgagee harmless from any and all liability, loss or damage which the Mortgagee may or might incur under any leases of the Premises or by reason of the Assignment

of Rents; and any and all such liability, loss or damage incurred by the Mortgagee, together with the costs and expenses, including reasonable attorneys' fees, incurred by the Mortgagee in the defense of any claims or demands therefor (whether successful or not), shall be so much additional indebtedness secured by this Mortgage, and the Mortgagor shall reimburse the Mortgagee therefor on demand.

Section 3.2. Declaration of Subordination to Leases. At the option of the Mortgages, this Mortgage shall become subject and subordinate, in whole or in part (but not with respect to priority of entitlement to insurance proceeds or any award in condemnation) to any and all leases of all or any part of the Premises upon the execution by Mortgages and recording thereof, at any time rereafter, in the Office of the Recorder of Deeds of the county wherein the Premises are situated, of a unilateral declaration to that effect.

ARTICLE IV

EVENTS OF DEFAULT AND REMEDIES

- (c) A court of competent jurisdiction shall enter an order, judgment or decree approving a petition filed against the Mortgagor, the General Partner, CMHDC, or any indemnitor under the Indemnity Agreement or guarantor under the Guaranty seeking any reorganization, dissolution or similar relief under any present or future federal, state or other statute, law or regulation relating to bankruptcy, insolvency or other relief for debtors, and such order, judgment or decree shall remain unvacated and unstayed for an aggregate of 60 days (whether or not consecutive) from the first date of entry thereof; or any trustee, receiver or liquidator of the Mortgagor, the General Partner, CMHDC, or any such indemnitor or guaranter or of all or any part of the Premises, or of any or all of the royalties, revenues, rents, issues or profits thereof, shall be appointed and such appointment shall remain unvacated and unstayed for an aggregate of 60 days (whether or not consecutive); or
- (d) A writ of execution or attachment or any similar process shall be issued or levied against all or any part of or interest in the Premises, or any judgment involving monetary damages shall be entered against the Mortgagor which shall become a lien on the Premises or any portion thereof or interest therein and such execution, attachment or similar process or judgment is not released, bonded, satisfied, vacated or stayed within 60 days after its entry or levy; or
- (e) If any representation or warranty of the Mortgagor contained in this Mortgage, or of the Mortgagor, the General Partner or CMHDC contained in any of the other Loan Documents or any certificate or other document delivered in connection with the loan evidenced by the Note, shall prove untrue or incorrect in any material respect; or
- (f) If any default by the Mortgagor shall occur under any commitment for permanent or take-out financing for the Premises, or under any multi-party agreement entered into in connection with such a commitment, and such default shall continue beyond any applicable notice and/or grace reciod, or if any such commitment shall be terminated, surrendered, modified or amended; or

Section 4.2. Acceleration upon Default; Additional Remedies. 

Section 4.3. Foreclosure; Expense of Litigation. When the indebtedness secured by this Mortgage, or any part thereof, shall become due, whether by acceleration or otherwise, the Mortgagee shall have the right to foreclose the lien hereof for such indebtedness or part thereof. 



Section 4.10. Mortgagee's Use of Deposits. The Mortgagor hereby represents and covenants that the proceeds of the Note will be used for the purposes specified in subparagraph 1(c) contained in Section 205/4 of Chapter 815 of the Illinois Compiled Statutes (1992), and that the indebtedness secured hereby constitutes a "business loan" within the meaning of that Section.
- Section 5.4. Lien for Service Charges and Expenses. At all times, regardless of whether any loan proceeds have been disbursed, this Mortgage secures (in addition to any loan proceeds disbursed from time to time) the payment of any and all origination fees, loan commissions, service charges, liquidated



damages, expense and advances due to or incurred by the Mortgages in connection with the loan to be secured hereby, all in accordance with the application and any loan commitment issued in connection with this transaction.

Section 5.5. Subrogation. To the extent that proceeds of the indebtedness secured by this Mortgage are used to pay any outstanding lien, charge or prior encumbrance against the Premises, the Mortgagee shall be subrogated to any and all rights and liens owned by any owner or holder of such outstanding liens, charges and prior encumbrances, and shall have the benefit of the priority thereof, irrespective of whether said liens, charges or encumbrances are released.




