DEED IN TRUST

The grantors, DENNIS J. MILLER and CYNTHIA P. In no case shall any party dealing with the Trustee in relation to the Premises, or to whom the Premises or any part thereof shall be conveyed, contracted to be sold, leased or mortgaged by the Trustee, be obliged to see to the application of any purchase money, rent, or money borrowed or advanced on the Premises, or be obliged to see that the terms of this trust have been complied with, or be obliged to inquire into the necessity or expediency of any act of the Trustee, or be obliged or privileged to inquire into any of the terms of said trust agreement; and every deed, trust deed, mortgage, lease or other instrument executed by the Trustee in relation to the Premises shall

If the title to any of the above lands is now or hereafter registered, the Registrar of Titles is hereby directed not to register or rote in the certificate of title or duplicate thereof, or memorial, the words "in trust," or "upon condition," or "with limitations," or words of similar import, in accordance with the statute in such case made and provided.

And the said grantors hereby expressly waive and release any and all right or benefit under and by virtue of any and all statutes of the State of Itlicois providing for the exemption of homesteads from sale on execution or otherwise.
