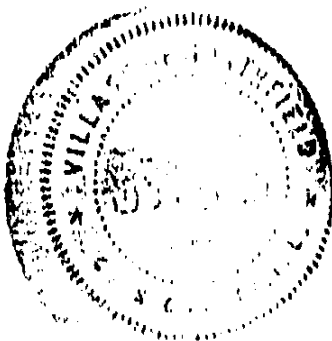

## ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF NORTHFIELD, COOK COUNTY, ILLINOIS
