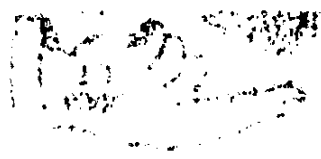

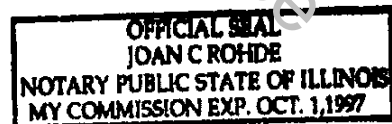

That part of the North 595.31 feet of the Southeast Quarter of the Northwest Quarter of Section 35, Township 39 North, Range 13 East of the Third Principal Meridian, bounded and described as follows:
