Amendment to Mortgage and Assignment of Rents (with Trustee)

"WHEREAS, the Beneficiary is indebted to Mortgagee in the principal sum of ONE HUNDRED SEVENTY SEVEN THOUSAND THREE HUNDRED DOLLARS (\$177,300.00) or so much thereof as may be disbursed and outstanding from time to time under a promissory noted dated March 1, 1995 from Beneficiary payable to the order of Mortgagee in the principal amount of \$177,300.00 (said note and all modifications, renewals or extensions thereof, the "Note") plus interest in the amount as provided in and evidenced by the Note, which Note is incorporated herein by this reference."
