Should default be made in the payment of ray monthly installment when due, or in the performance of any provision or condition contained in the Mortgage securing this Note, the whole sum of principal and fell accrued interest shall become immediately due and payable at the option of the holder and regardless of any prior forbearance. Interest shall accrue following any default hereunder at the rate of Four (4%) percent per annum in excess of the stated interest rate at time of default ("Default Rate"). Said Default Rate scall not be limited by interest rate earlier described in this modification agreement
