Further, Mortgagor covenants and agrees as follows:

- 1. - 14. "Maturity" means the earlier of (a) five years from the date of the Note; or (b) the day when the Mortgagee accelerate and declares the balance of the Line of Credit to be due and payable pursuant to a Default. By agreement of the Mortgagor and Mortgagee, the Maturity of the Note and this Mortgage may be extended.
- 15. When the indebtedness secured hereby shall become due whether by acceleration or otherwise, Mortgagee shall have the right to foreclose the lien of this Mortgage.
