- In the event that any provision in this Mortgage shall be inconsistent 17. with any provision of the Illinois Mortgage Foreclosure Law, as amended (Chapter 110, Section 1101, et seq., Ill. Rev. Without limiting the generality of the foregoing, all expenses incurred by Mortgagee to the extent reimburseole under Section 15-1510 and 15-1512 of the IMF Act, whether incurred before or after any decree or judgment of foreclosure shall be added to the indebtedness hereby secured or by the judgment of foreclosure.
