GRANT OF MORTGAGE. Indebtedness. The word "Indebtedness" means all principal and interest payable under the Note and any amounts expended or advanced by Londor to discharge obligations of Grantor or expenses incurred by Londor to enforce obligations of Grantor under this Mortgage, together with interest on such amounts as provided in this Mortgage. At no time shall the principal amount of Indebtedness secured by the Mortgage, not including sums advanced to protect the security of the Mortgage, exceed the note amount of \$15,000.00.

Note. The word "Note" means the promissory note or credit agreement dated May 5, 1995, in the original principal amount of \$15,000.00 from Granter to Lender, together with all renewals of, extensions of, modifications of, refinancings of, consolidations of, and substitutions for the promissory note or agreement. The interest rate on the Note is 10.250%. The maturity date of this Mortgage is May 5, 2000.

Personal Property. The words "Personal Property" mean all equipment, fixtures, and other articles of personal property new or hereafter extend by Granter, and new or hereafter attached or affixed to the Real Property; together with all accessions, parts, and additions to, all replacements of, and all substitutions for, any of such property, and together with all proceeds (including without limitation all insurance proceeds and refunds of premiums) from any sale or other disposition of the Property.

Property. The word 'Property' means collectively the Real Property and the Personal Property.

Real Property. The words "Real Property" mean the property, interests and rights described above in the "Grant of Mortgage" section.

Rents. The word "Hents" meens all present and future rents, revenues, income, issues, revalties, profits, and other benefits derived from the Property.

THIS MORTGAGE, INCLUDING THE ASSICNMENT OF RENTS AND THE SECURITY INTEREST IN THE RENTS AND PERSONAL PROPERTY, IS GIVEN TO SECURE (1) PAYMENT OF THE INDEBTEDNESS AND (2) PERFORMANCE OF ALL OBLIGATIONS OF GRANTOR UNDER THIS MORTGAGE. THIS MORTGAGE IS GIVEN AND ACCEPTED ON THE FOLLOWING TERMS:

PAYMENT AND PERFORMANCE. Except as otherwise provided in this Mortgage, Grantor shall pay to Lender all amounts secured by this Mortgage as they become and shall strictly perform all of Grantor's obligations under this Mortgage.

POSSESSION AND MAINTENANCE OF THE PROPERTY Grantor agrees that Grantor's possession and use of the Property shall be governed by the following provisions:

DUE ON SALE - CONSENT BY LENDER. Lender may, at its option, declare immediately due and payable all sums secured by this Mortgage upon the sale or transfer, without the Lender's prior witter, consent, of all or any part of the Real Property, or any interest in the Real Property. A "sale or transfer" means inc. conveyance of Real Property or any right, title or interest therein; whether legal, beneficial or equitable; which evoluntary or involuntary; whether by outright sale, deed, installment sale contract, land contract, contract for goed, leasehold interest with a term greater than three (3) years, lease-option contract, or by sale, assignment, or transfer of any beneficial interest in or to any land trust holding title to the Real Property, or by any other method of conveyance of Real Property interest. If any Grantor is a corporation, partnership or limited liability company, transfer also includes any change in ownership of more than twenty-five percent (25%) of the voting stock, partnership interests or limited liability company interests, as the case may be, of Grantor. However, this option shall not be exercised by Lender if such exercise is prohibited by federal law or by Illinois law.

TAXES AND LIENS. The following provisions relating to the taxes and liens on the Property are a part of this Mortgage.

Payment. Grantor shall pay when due (and in all events prior to delinquency) all taxes, payroll taxes, special taxes, assessments, water charges and sewer service charges levied against or on account of the Property, and shall pay when due all claims for work done on or for services rendered or material furnished to the Property. extended coverage endersements on a replacement basis for the full insurable value covering all improvements on the Real Property in an amount sufficient to avoid application of any coinsurance clause, and with a standard mertgagee clause in tavor of Lender. Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Lender. Granter shall deliver to Lender certificates of coverage from each insurer containing a stipulation that coverage will not be cancelled or diminished without a minimum of ten (10) days' prior written notice to Lender and not containing any disclaimer of the insurer's liability for failure to give such notice. Each insurance policy also shall include an endersement providing that coverage in favor of Lender will not be impaired in any way by any act, omission or default of Granter or any other person. Application of Proceeds. Granter shall promptly notify Lender of any loss or damage to the Property if the estimated cost of repair or replacement exceeds \$5,000.00. Lender may make proof of loss if Granter fails to do so within facen (15) days of the casualty. Whether or not Lender's security is impaired, Lander may, at its election, apply the proceeds to the reduction of the Indebtedness, payment of any lien affecting the Property, or the restoration and repair of the Property.

EXPENDITURES BY Legicia. If Grantor fails to comply with any provision of this Mortgage, including any obligation to maintain Existing Indobtodness in good standing as required below, or if any action or proceeding is commenced that would materially affect Londer's interests in the Property, Lender on Grantor's behalf may, but shall not be required to, take any action that Londer deems appropriate. WARRANTY; DEFENSE OF TITLE. The following provisions relating to ownership of the Property are a part of this Mortgage.

Title. Grantor warrants that: (a) Grantor holds good and marketable title of record to the Property in lee simple, free and clear of all liens and encumbrances other than those set forth in the Real Property description or in the Existing Indebtedness section below or in any allo insurance policy, title report, or final title opinion issued in favor of, and accepted by, Lendar in connection with this Mortgage, and (b) Grantor has the full right, power, and authority to execute and deliver this Mortgage to Lendar.

Defense of Title. Subject to the exception in the paragraph above. Grantor warrants and will forever defend the title to the Property against the lawful claims of all persons.

EXISTING INDEBTEDNESS. The following provisions concerning existing indebtedness (the "Existing Indebtedness") are a part of this Mortgage.

Existing Lien. The lien of this Mortgage securing the Indebtedness may be secondary and inferior to the lien securing payment of an existing obligation with an account number of 167 (73 to Home Savings of America FSB described as: Mortgage Loan dated March 3, 1994 and recorded March 19, 1994 as Document Number 94227741. The existing obligation has a current principal balance of approximately \$112,000.00 and is in the original principal amount of \$113,600.00. The obligation has the following payment terms: payment of principal and interest monthly. Grantor expressly covenants and agrees to pay, or 200.00 the payment of, the Existing Indebtedness and to prevent any default on such indebtedness, any default under any security documents for such indebtedness.

Default. If the payment of any installment of principal or any interest on the Existing Indebted less is not made within the time required by the note evidencing such Indebtedness, or should a default occur under the instrument securing such indebtedness and not be cured during any applicable grace period therein, then, at the option of Lender, the Indebtedness secured by this Mortgage shall become Immediately due and payable, and this Mortgage shall be in default.
