All replacements and additions shall also be covered by this Security Instrument. All of the foregoing is referred to in this Security Instrument as the "Property."

BORROWER COVENANTS that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property and that the Property is unencumbered, except for encumbrances of record. (a) Change Dates

The initial fixed interest rate will change to an adjustable interest rate on the first day of June 2005, and on the first day of the month every 6th month dierester. Each date on which the adjustable interest rate could change is called a "Change Date."

(b) The Index

Beginning with the first Change Date, the interest rate will be based on an large. Subject to the limits stated in Section 1(d) on the following page, this rounded amount will be the new interest rate until the next Change Date.

The Lander will then determine the amount of the monthly payment that would be sufficient to repay the unpaid principal balance as of the Chango Date in full on the Maturity Date at the new interest rate in substantially equal payments. The interest rate at the first Change Date will not be greater than 16.125 % or less than 12.250 %.
