It or they are hereby given the right of taking over said property, managing same, renting same and collecting the rents thereon, and the net income so collected shall be credited upon the indebtedness and/or coverants in connection herewith.

If the Mortgagor should fall or refuse to make any of the payments herein before recited, either principal, interest taxes or insurance premiums as same mature and become due and payable, then at the option of the Mortgagee, its assigns or the holders of the indebtedness, all the remaining unpaid portion thereof shall become due and payable, and the lien of this instrument subject to foreclosure by suit fixer in Chancery Court of the country in which the above described property is situated. Failure to exercise the option herein granted to declare the entire training due and payable on the dafault shall not be a waiver to exercise the option at any subsequent default.
