

- 5. GOLLECTION OF RENT. Owner shall give notice of Bank's rights to all Horit and notice of direct payment to Black to those obligated to pay Horit on Event of Default, Owner may continue to collect all Ront from the Linagus on the Property now due or which may become due. Owner eigens to direct all tenants that in certain instances they may be required to pay Rent due or to become due to Bank. Owner shall endorse and deliver to Bank any money orders, checks or drafts which represent Rent from the above-described Property, apply the proceeds to the Obligations, and give notice of Bank's rights in any of said Rent and notice of direct payment to Bank to those obligated to pay such Rent. Bank shall be the creditor of each Lessee in respect to assignments for the benefit of creditors, bankruptcy, reorganization, rearrangument, insolvency, dissolution or receivership proceedings by Lessee, and Owner shall invinediately pay over to Bank all sums Owner may receive as creditor from such actions or proceedings. Also, Bank may collect or receive all payments paid by any Lessee, whether or not pursuant to the terms of the Leases, for the dight to terminate, cancel or modify the Leases, and Owner shall immediately pay over to Bank all such payments as Owner may receive from any Lessee. Bank shall have the option to apply any amounts received as such creditor to the Obligations. The collection or receipt of any payments by Bank shall not constitute Bank as boing a mortgagee in possession.
- B. APPLICATION OF COLLATERAL PROCEEDS. Any Rent or other payments received or to be received by virtue of the Collateral, will be applied to any anxiounts Borrower awas Bank on the Obligations and shall be applied that to costs and expenses, then to accouse interest and the balance, if any, to principal except as otherwise required by law.

 - B. not to amond, modify, extand or in any manner after the terms of an 1 Jacos, or cancel or terminate the same, or accept a surrender of any premises covered by such Leases without the prior written consent of Bunk in each instance;
 - c. to observe and perform all obligations of Lessor under the Leases, and to give written prompt notice to Bank of any default by Lessor or Lesson under any Leases;
 - D. to notify each Leason in writing that any deposits previously delivered to Owner have chen retained by Owner or assigned and delivered to Bank as the case may be:
 - E. to appear in and defend any action or proceeding pertaining to the Leases, and, upon the request of Bank, to do so in the name and on behalf of Bank but at the expense of Owner, and to pay all costs and expenses of Bank, including reasonable attorneys' fees to the extent not prohibited by law, in any such action or proceeding in which Bank may appear;

 - H. that if the Leases provide for abatement of Rent during repair due to fire or other casually, Bank shall by clavided satisfactory insurance coverage; and
 - I. that the Leases shall remain in full force and effect regardless of any merger of the Lessor's and Lessee's interests.
- 9. EVENTS OF DEFAULT. Owner shall be in default upon the occurrence of any of the following events, circumstances or conditions (Events of Default):
 - A. Failure by any party obligated on the Obligations to make payment when due; or
 - B. A default or breach by Borrower, Owner or any co-signer, endorser, surety, or guaranter under any of the terms of this Agreement, the Note, any construction loan agreement or other loan agreement, any security agreement, mortgage, deed to secure debt, deed of trust, trust deed, or any other document or instrument evidencing, guarantying, securing or otherwise relating to the Obligations; or
 - C. The making or turnishing of any varial or written representation, statement or warranty to Bank which is or becomes false or incorrect in any material respect by or on behalf of Owner, Borrower, or any one of them, or any co-signer, endorser, surely or guaranter of the Obligations; or
 -). Failure to obtain or maintain the insurance coverages required by Bank, or insurance as is customary and proper for the Collateral (as herein defined); or
 - E. The death, dissolution or insolvency of, the appointment of a receiver by or on behalf of, the assignment for the benefit of creditors by or on behalf of, the voluntary or involuntary termination of existence by, or the commencement of any proceeding under any present or future federal or state insolvency, bankruptcy, reorganization, composition or debtor relief law by or against Owner, Bottower, or any one of them, or any co-signer, endorser, surety or guaranter of the Obligations; or
 - F. A good faith bolief by Bank at any time that Bank is insecure with respect to Borrower, or any co-signer, endorser, surety or quaranter, that the prospect of any payment is impaired or that the Collateral (as berein defined) is impaired; or
 - G. Faiking to pay or provide proof of payment of any tax, assessment, rent, insurance promium, escrew or escrew deficiency on or before its due date; or
 - H. A material adverse change in Owner's business, including ownership, management, and financial conditions, which in Bank's opinion,

- .d HEMEDIES ON DEFAULT. At the option of Bank, all er any part of the principal of, and account interest on, the Obligations shalf become inmodiately due and payable without notice or dumand, upon the occurrence of an Event of Default or at any time thereafter by Mortgager under the Mortgage, Bank, at Bank's option, shall have the right to exercise any or all of the following remedies:
 - A. To continue to collect directly and retain fixed in Bank's name without taking possession of the Property and to demand, collect, receive, and sue for the Ront, giving proper receipts and releases, and, after deducting all reasonable expenses of collection, apply the balance as legally primated to the Note, that to accrued interest and then to principal.
 - 1). To recover reasonable attorneys' less to the extent not prohibited by law.
 - To doctare the Obligations invincinately due and payable, and, at Bank's option, exercise any of the remodes provided by law, the Note, the Mortgage or this Agreement.
 - To enter upon, take possession of, manage and operate all or any part of the Property, make, modify, enforce or cancel any Leases, evict any Leases, increase or reduce Rent, descrite, clean and make repails, and do any act or incur any cost Bank shall deem proper to protect the Property as fully as Owner coald do, and to apply any lunds collected from the operation of the Property in such order as Bank may deem proper, including, but not limited to, payment of the following: operating expanses, management, brokerage, attorneys' and accountants' loss, the Obligations, and toward the maintenance of reserves for repair or replacement. Bank may take such action without regard to the adequacy of the security, with or without any action or proceeding, through any person or agent, mortgages under a mortgage, or receiver to be appointed by a court, and irrespective of Owner's possession.

The collection and application of the Rent or the entry upon and taking possession of the Property as set out in this section shall not cure or waive any default, or modify or waive any notice of default under the Note. Mortgage or this Agreement, or invalidate any act done pursuant to such notice. The enforcement of such rank dy by Bank, once exercised, shall continue for so long as Bank shall elect, notwithstanding that such collection and application of Rent may have could the original default. If Bank shall thereafter elect to discontinue the exercise of any such remady, the same or any other remady under the law-the Note, Mortgage or this Agreement may be asserted at any time and from time to time following any subsequent default. The word "default" has the same meaning as contained within the Note or any other instrument evidencing the Obligations, and the Mortgage, or any other document securities, quarantlying or otherwise relating to the Obligations.

In addition, upon the occurrence of any 5 and of Default, Bank shall be entitled to all of the remodes provided by law, the Note and any related loan documents. All rights and remodes are compliative and not exclusive, and Bank is entitled to all remodes provided at law or equity, whether or not expressly set forth.

11. ENVIRONMENTAL LAWS AND HAZARDOUS SUBSTANCES

A. As used in this paragraph:

- (1) "Environmental Law" means, without introduction, the Comprehensive Environmental Response, Compensation, and Liability Act ("CERCLA", 42 U.S.C. 9601 et seq.), all fer oral, state and local laws, regulations, ordinances, court orders, attorney general opinions or interpretive letters concerning the public health, safety, welfare, environment or a Hazardous Substance (as defined herein).
- (2) "Hazardous Substance" means any toxic, radicactive or hazardous material, waste, pollutant or contaminant which has characteristics which render the substance dangerous or potentially dangerous to the public health, safety, welfare or the environment. The term includes, without limitation, any substances defined as "hazardous material," "toxic substances," "hazardous waste" or "hazardous substance" under any Er vir amental Law.
- B. Owner represents, warrants and agrees that, except as previously disclorud and acknowledged in writing:
 - (1) No Hazardous Substance has been, is or will be located, transported, manufactured, treated, refined, or handled by any person on, under or about the Property except in the ordinary cours; of business and in strict compliance with all applicable Environmental Law.
 - (2) Owner has not and shall not cause, contribute to or permit the release of any Kazardous Substance on the Property.
 - (3) Owner shall immediately notify Bank it: (a) a release or threatened release of Hazardous Substance occurs on, under or about the Property or migrates or threatens to migrate from nearby property; or (b) there is a violation of any Environmental Law concerning the Property. In such an event, Owner shall take all necessury remedial action in accordance with any Environmental Law.
 - (4) Owner has no knowledge of or reason to believe there is any pending or threatened ir vestigation, claim, or proceeding of any kind relating to (a) any Hazardous Substance located on, under or about the Property or (b) any violation by Owner or any tenant of any Environmental Law. Owner shall immediately notify Bank in writing as soon a Owner has reason to believe there is any such pending or threatened investigation, claim, or proceeding. In such an event, Part, has the right, but not the obligation, to participate in any such proceeding including the right to receive copies of any necessarily such proceedings.
 - (5) Owner and every tenant have been, are and shall remain in full compliance with any applicable Errviron nor tal Law.
 - (5) There are no underground storage tanks, private dumps or open wells located on or under the Property and no such tank, dump or well shall be added unless Bank first agrees in writing.
 - (7) Owner will regularly inspect the Property, monitor the activities and operations on the Property, and confirm that all permits, licenses or approvals required by any applicable Environmental Law are obtained and complied with.
 - (8) Owner will peimit, or cause any tenant to permit, Bank or Bank's agent to enter and inspect the Property and review all records at any reasonable time to determine: (a) the existence, location and nature of any Hazardous Substance on, under or about the Property; (b) the existence, location, nature, and magnitude of any Hazardous Substance that has been released on, under or about the Property; (c) whether or not Owner and any tenant are in compliance with any applicable Environmental Law.
 - (9) Upon Bank's request, Owner agrees, at Owner's expense, to engage a qualified environmental engineer to prepare an environmental audit of the Property and to submit the results of such audit to Bank. The choice of the environmental engineer who will perform such audit is subject to the approval of Bank.
 - (10) Bank has the right, but not the obligation, to perform any of Owner's obligations under this paragraph at Owner's expense.
 - (11) As a consequence of any breach of any representation, warranty or promise made in this paragraph, (a) Owner will indemnity and hold Bank and Bank's successors or assigns harmless from and against all losses, claims, demands, liabilities, damages, cluanup, response and remediation costs, penalties and expenses, including without limitation all costs of titigation and reasonable atterneys' fees, which Bank and Bank's successors or assigns may sustain; and (b) at Bank's discretion, Bank may release this Agreement and in return Owner will provide Bank with collateral of at least equal value to the Property secured by this Agreement without prejudice to any of Bank's rights under this Agreement.
 - (12) Notwithstanding any of the language contained in this Agreement to the contrary, the terms of this paragraph shall survive any

- D. INTEGRATION CLAUSE. This written Agramment and all documents executed concurrently herewith, represent the entire understanding between the parties as to the Obligations and may not be contradicted by evidence of prior, contemporareaus, or assequent are agramments of the parties.
- FURTHER ASSURANCES. Owner, upon request of Bank, agrees to execute, acknowledge, deliver and record or line such further final currents or a source as may be required by Bank to secure the fote or confirm any figure
- GOVERNING LAW. This Agreement shall be governed by the laws of the State of ILLIPTOIS, provided that such laws are not otherwise proempted by todors rows and regulations.
