31. NO CONFORMED COPY

33. LENDER'S RIGHTS TO BORROWER FAILS TO KEEP PROMISES AND AGREEMENTS

Notwithstanding Lender's acceleration of the Sums Secured by this Mortgage and to Borrower's breach, Lender, at its sole option, may discontinue any proceedings begun by Lender to enforce this Mortgage, any time prior to entry of a judgment enforcing this Mortgage if:

35. ASSIGNMENT OF RENTS

The text of Covenant 19 of this Mortgage is deleted and replaced with the following:
