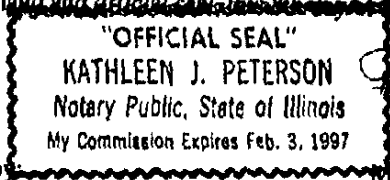

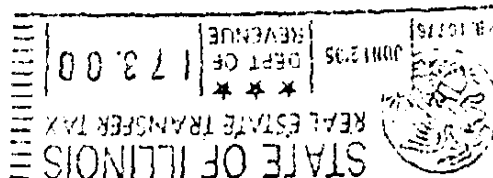
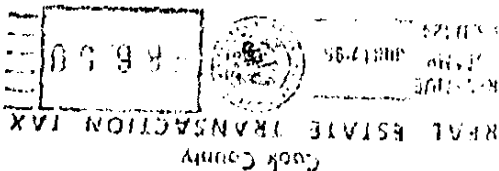
LEGAL DESCRIPTION
