SPECIAL WARRANTY DEED

Unit 2F and P-15 in 420 West Grand Condominium as delineated on the Plat of Survey of the following described parcel of real estate: Lots 1 through 10, both inclusive, in Block 5 in the Assessor's Subdivision of the Kingsbury Tract (South of Erie Street and East of the Chicago River) in the East Half of the Northwest Quarter of Section 9, Township 39 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois, which Plat of Survey is attached as Exhibit D to the Declaration of Condominium recorded November 17, 1993 in the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 93959738, as amended from time to time, together with its undivided percentage interest in the common elements in Cook County, Illinois.

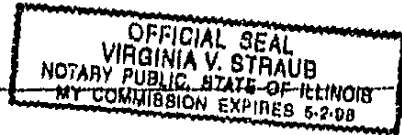

EXHIBIT A

Permitted Exceptions

1. Real estate taxes not yet due and payable.
2. Special taxes or assessments for improvements not yet completed and other assessments or instruments thereof not due and payable at the time of the Closing.
3. Applicable zoning and building laws and ordinances.
4. The Declaration of Condominium, including any and all exhibits thereto and amendments thereof as permitted by the Declaration and the Act.
5. Provisions of the Illinois Condominium Property Act ("Act").
6. Easements, covenants, conditions, agreements, building lines and restrictions of record which do not materially affect the use of the Premises as a single family residence.
7. Acts done or suffered by Grantee or anyone claiming by, through, or under Grantee.
8. Liens, encroachments and other matters as to which the title insurer commits to insure Grantee against loss or damage.
9. Encroachment of the premises onto a public way as shown on the survey of the premises attached to the Declaration.
