### FIRST AMENDMENT TO THE DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS AND COVENANTS FOR COURTLAND SQUARE CONDOMINIUM BUILDING NO. 13 ASSOCIATION

This document is recorded for the purpose of amending the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants (hereafter the "Declaration") for the Courtland Square Condominium Building No. 13 Association (hereafter the "Association"), which Declaration was recorded in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property") legally described in Exhibit "A," which is attached here o and made a part hereof.

This Amendment is adopted pursuant to the provisions of Article 13.08 of the aforestid Declaration. Said section provides that this Amendment, the text of which is set forth below, shall become effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois, of an instrument in writing setting forth the change, signed and acknowledged by the members of the Board of Managers (hereafter the "Loard") and by the Owners having at least two-thirds (2/3) of the total ownership of all units, and provided further that it contains an affidavit by an officer of the Board certifying that a copy of the change has been sent by certified mail to all mortgagees, having bona fire liens of record against any unit ownership, not less than 10 days prior to the date of such Amendment.

#### **RECITALS**

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been subjected to the easements, restrictions and covenants contained therein; and

WHEREAS, the Board and the Owners desire to amend the Declaration in order to provide for the orderly operation of the Property; and

WHEREAS, the following amendment has been approved in writing by the signatures of the Board and two-thirds (2/3) of the Owners, in compliance with Article 13.08 of the Declaration, and due notice having been provided to all mortgagees holding bona fide liens of record against any unit ownership.

NOW, THEREFORE, the Declaration of Condominium for Courtland Square Condominium Building No. 13 is hereby amended in accordance with the text which follows (Additions in text are indicated by <u>underline</u>; deletions by <del>strike-outs</del>):

Page 1



Article VIII of the Declaration is amended by adding the following Section: 1.

8.14 Lease of Units.

- Notwithstanding the foregoing provisions of this Article VIII, rental or leasing of Units is prohibited until such time as an Owner has resided in the Unit for not less than one year. In addition, to meet special situations and to avoid undue hardship or practical idfficulties, the Board may, but is not required to grant permission to a Unit Owner to lease his Unit to a specified lessee for a period of not less than six (6) months nor more than one (1) year on such reasonable terms as the Board may establish. Such permission may be granted by the Board only upon written application by the Owner to the Board. The Board shall respond to each application in writing within thirty (30) days of the submission thereof. The Board has sole and complete discretion to approve or disapprove any Owner's application for a lease. The Board's decision shall be final and binding.
- Subsection (a) of this Section 8.14 shall not apply to the rental or (b) leasing of Units by any Owner or contract purchaser of a Unit holding title on the effective date of this Amendment.
- Subsection (a) of this Section 8.14 shall not apply to the rental or (C) leasing of Units to the immediate franky members of a Unit Owner. For purposes of this section, an immediate family member shall be deemed to be a parent, grandparent or child of the Unit Owner.
- This Amendment shall be effective upon recordation in the Office of the 2. Recorder of Deeds of Cook County, Illinois.
- Except to the extent expressly set forth hereinabove, the remaining 3. provisions of the Declaration shall continue in effect without change. Office
