RIDER - LEGAL DESCRIPTION

PARCEL 1:

THE NORTH 255 FEET OF THE EAST 2.23 FEET OF THE WEST 177.23 FEET OF THE NORTH 30 RODS OF THE EAST 10 ACRES OF THE FOLLOWING TRACT OF LAND SITUATED IN THE NORTHEAST 1/4 OF SECTION 23, TOWNSHIP 42 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, DESCRIBED AS FOLLOWS: COMMENCING 10 RODS SOUTH OF THE NORTHWEST CORNER OF SAID NORTHEAST 1/4; THENCE EAST 160 RODS; THENCE SOUTH 30 RODS; THENCE WEST 20 RODS; THENCE SOUTH 14 RODS; THENCE WEST 140 RODS; THENCE NORTH 44 RODS TO THE POINT OF BEGINNING.

PARCEL 2:

THAT PART OF THE SOUTH 15 RODS (247.5 FEET) OF THE NORTH 25 RODS (412.5 FEET) OF THE WEST 160 RODS (2,640 FEET) OF THE NORTHEAST 1/4 OF SECTION 23, TOWNSHIP 42 NORTH, KANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, LYING EAST OF THE WEST 1/7.23 FEET OF THE NORTH 30 RODS OF THE EAST 10 ACRES OF THE FOLLOWING TRACT OF LAND SITUATED IN THE NORTHEAST 1/4 OF SECTION 23, AFORESAID, DESCRIBED AS FOLLOWS: COMMENCING 10 RODS SOUTH OF THE NORTHWEST CORNER OF SAID NORTHEAST 1/4 THENCE EAST 160 RODE THENCE SOUTH 30 RODS THENCE WEST 20 RODS; THENCE SOUTH 14 RODS THENCE WEST 140 RODS THENCE NORTH 40 RODS TO THE POINT OF BEGINNING, EXCEPT THEREFROM THE EAST 355 FEET OF SAID WEST 160 RODS (2,640 FEET) ALSO KNOWN AND DESCRIBED AS THE WEST 1/2.77 FEET OF THE NORTHEAST 1/4 OF SAID SECTION 23, TOWNSHIP 42 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

PARCEL 3:

EASEMENT FOR THE BENEFIT OF PARCELS 1 AND 2 AS CREATED BY THE DECLARATION OF EASEMENTS MADE BY LASALLE NATIONAL BANK, A NATIONAL BANKING ASSOCIATION, AS TRUSTEE UNDER TRUST AGREEMENT DATED JUNE 4, 1954 AND KNOWN AS TRUST NUMBER 16680 AND OTHERS DATED MAY 19, 1955 AND RECORDED JUNE 9, 1955 AS DOCUMENT 16263326 FOR INGRESS AND EGRESS OVER THE LAND DESCRIBED AS FOLLOWS: THE SOUTH 33 FEET OF THE NORTH 12 RODS OF THE WEST 160 RODS OF THE NORTHEAST 1/4 OF SECTION 23, TOWNSHIP 42 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN (EXCEPT THE WEST 2126.5 FEET THEREOF), AND THE EAST 14.27 FEET OF THE WEST 2126.5 FEET OF THE SOUTH 247.5 FEET OF THE NORTH 412.5 FEET OF THE NORTHEAST 1/4 OF SECTION 23, TOWNSHIP 42 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, AND THE EAST 18.73 FEET OF THE WEST 2112.23 FEET OF THE SOUTH 255 FEET OF THE NORTH 420 FEET OF THE NORTHEAST 1/4 OF SECTION 23, TOWNSHIP 42 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, EXCEPT THAT PART THEREOF FALLING IN PARCELS 1 AND 2 AFORESAID, ALL IN COOK COUNTY, ILLINOIS.
