## Secondary Rasements

4. The casement granted herein includes incidental rights of wintenance, repair, and replacement.

#### Construction of Facilities

- 5. In addition to the easement, rights, and privileges herein conveyed, Grantee shall have the right to use so much of the surface of the above-described property of Grantor as may be reasonably necessary to construct and install within the easement gracted hereby the facilities contemplated by this grant.
- 6. Incident to the Grent of Rasement and in consideration thereof, it is covenanted and agreed between the grantor and the grantee as follows:
- (a) The Grantee agrees that any activity authorized by this Grant of Easement shall be conducted by the Grantee and its authorized agents, servants, employees or contractors in a good, workmanlike manner, at the sole expense of the Grantee.
- (b) The Grantee shall remove any spoilage placed upon easement area or adjacent to the easement area during construction by the Grantee or its contractor and shall seed or otherwise restore the area to its original condition upon the conclusion of the easement.
  - (c) The Grantee accepts this easement by exercising the rights granted herein.
  - (d) The Grantee agrees to save and hold Grantors harmless from mechanic lien claims and all other claims, causes of action, suits, damage or demands that arise directly from the negligence of the Grantee or its authorized agents, servants, employees or contractors in the exercise of the Grantees rights hereunder.
  - (e) The Grantors reserve the right to use the easement premises and their adjacent property in any manner that will not prevent or interfere with the exercise by the Grantee of the permanent rights granted hereunder.

In the event of any controversy, claim, or dispute relating to this instrument or the breach thereof, the prevailing party shall be entitled to recover from the losing party reasonable expenses, attorney's fees, and costs.
