Borrower covenants that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered with the exception of those items, if any disted in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property, and that Borrower will warrant and defend generally the title to the P operty against all claims and demands, subject to any mortgages, encumbrances, cicularations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's inverest in the Property or of record on the date hereof.

#### COVENANTS

Be rrower and Lender covenant and agree as follows

- 1. Payment of Principal and Interest. Borrower shall promptly pay when due without setoff, recompount or deduction, the principal of and interest on the indebtednes incurred pursuant to the Agreement (including future advances), together with any fees and charges as provided in the Agreement.
- 2. Application of Payneurs. Unless applied to law provides otherwise all payments received by Lender under the Agreement and paragraph 1 hereof small be applied by Lender first in payment of any advance made by Lender pursuant to this Mortgage, then to fees and charges and interest parable pursuant to the Agreement, then to the principal amounts mistanding under the Agreement.
- 3. Charges: Liens. Borrower thalf promptly pay or cause to be paid all taxes, assessments and other charges, tines and impositions attributable to the Property which may attain a priority over this Morigage, and leasehold payments or ground reads, if any, including all payments due under any mortgage disclosed by any title insurance policy insuring Lender's interest in the Property or of record on the date hereof. Is trower shall, promptly furnish to Lender all notices of amounts due under this paragraph and receipts evidencing such payment. Borrower shall promptly discharge any lien which has priority over this Mortgage, except for the lien of any mortgage disclosed by the title insurance policy insuring Lender's interest in the Property or of record on the date here if; provided, that Forrower shall not be required to discharge any such lien so long as Borrower shall agree in writing to the payment of the obliquation secured by such lien in a manner acceptable to Lender, or shall in good faith contest such lien by, or defend enforcement of such lier in, legal proceedings which operate to prevent the enforcement of the lien or forfeiture of the Property or any part thereof.
- 4. Hazard Insurance. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage" and such other hazards as Lender may require and in such amounts and for such periods as Lender may require; provided, that Leoder shall not require that the amount of such coverage exceed that amount of coverage required to pay the sums secured by this wortgage and any other mortgage on the Property.

The insurance carrier providing the insurance shall be chosen by Dorrower subject to approval of Lender; provided, that such approval shall not be unreasonably withheld. All premiums on insurance policies shall be paid in a timely manner when due.

All insurance policies and renewals thereof shall be in form acceptable to Lender and shall includ; a standard mortgage clause in favor of and in form acceptable to Lender. Upon request of Lender, Lender shall have the right to hold the policies and renewals thereof, and Borrower shall promptly furnish to Lender all renewal notices and all receipts of paid premiums. In the event of loss, Borrower shall give prompt notice to the insurance carrier and Lender. Lender may make proof of loss if not made promptly by Borrower.

Unless Lender and Borrower otherwise agree in writing, insurance proceeds shall be applied to restoration or repair of the Property damaged, provided such restoration or repair is economically feasible and the security of this Mortgage is not thereby impaired. If such restoration or repair is no economically feasible or if the security of this Mortgage would be impaired, the insurance proceeds shall be applied to be sums secured by this Mortgage, with the excess, if any, paid to Borrower. If the Property is abandoned by Borrower, or if Borrower fails to respond to Lender within 30 days from the date notice is mailed by Lender to Borrower that the insulance carrier offers to settle a claim for insurance benefits, Lender is authorized to collect and apply the insurance proceeds at Lender's option either to restoration or repair of the Property or to the sums secured by this Mortgage.

The procurement of insurance or the payment of taxes or other liens or charges by Lender shall not be a waiver of Lender's right to accelerate the maturity of the indebtedness secured by this Mortgage.
- 11. Remedies Cumulative. All remedies provided in this Mortgage are distinct and cumulative to any other right or remedy under this Mortgage or afforded by law or equity, and may be exercised concurrently, independently or successively.
- 12. Successors and Assigns Bound; Joint and Several Liability; Captions. The covenants and agreements herein contained shall bird, and the rights hereunder shall inure to the respective successors and assigns of Lender and Borrower. All covenants and agreements of Borrower shall be joint and several. The captions and headings of the paragraphs of this Mortgage are for convenience only and are not to be used to interpret or define the provision, hereof.
- 13. Notice. Except for any notice required under applicable law to be given in another manner, (a) any notice to Borrover provided for in this Mortgage shall be given by mailing such notice by regular, first class mail, addressed to Borrower at the Property Acdress or at such other address as Borrower may designate by notice to Lender as provided herein, and (b) any

- Governing Law, Severability. This Mortgage shall be governed by applicable federa, law and the law of the State of Illinois. In the event that any provision or clause of this Mortgage or the Agreement conflicts with applicable law, such conflict shall not affect other provisions of this Mortgage or the Agreement which can be given effect without the conflicting provisions, and to this end the provisions of the Mortgage and the Agreement are declared to be severable.
  - 15. Borrower's Copy. Borrower shall be furnished a conformed copy of the Agreement and of this Mortgage at the time of execution or after recordation hereof.
  - Revolving Credit Loan. This Mortgage is given to secure a revolving credit loan, and shall secure not only presently existing indeptedness under the Agreement but also future advances, whether such advances are obligatory or made at the option of the Leggler, or otherwise, to the Expiration Date or as may be extended by Lender provided that in no event shall the Expiration Date by extended beyond 20 years from the date hereof, (and nothing herein obligates Lender to grant any such extension) and any amounts (including by extension) shall apply to the same extent as if such future advances were made on the date of the execution of this. Mortgage, although there may be no advance made at the time of execution of this Mortgage and although there may be no may be doess secured hereby outstanding at the time my advance is made. If it becomes necessary to enforce or foreclose this Mortgage including by judicial proceeding, Lender shall be entitled to collect all expenses of collection, enforcement and foreclosure, including but not limited to reasonable attorneys' fees, court costs and costs of documentary evider to abstracts and title reports.
  - 18. Assignment of Rents; Appointment of Receiver; Lender in Possession. As additional security hereunder, Borrower hereby assigns to Lender the rents of the Property, provided that Borrower shall, prior to acceleration under paragraph 17 hereof or abandonment of the Property, have the right to collect and retain such rents as they occome due and payable

Upon acceleration under paragraph 17 hereof or abandonment of the Property, and at any time prior to the expiration of any period of refemption following judicial sale, Lender, in person, by agent or by judicially appointed receiver, shall be entitled to enter up on, take possession of and manage the Property and to collect the rents of the Property including those past due. All rents collected by Lender or the receiver shall be applied first to payment of the costs of management of the Property and collection of rents, including, but not limited to receiver's fees, premiums on receiver's bonds and reasonable attorneys's fees, and then to the sums secured by this Mortgage. Lender and the receiver shall be liable to account only for those rents actually received.

19. Ecleuse. Upon payment of all sums secured by this Mortgage and termination of the Agreement, Lender shall release this Mortgage without charge to Borrower. Lender shall pay all costs of recordation, if any. To the full extent allowed by the provisions of applicable law. Borrower hereby waives any and all rights of redemption from sale under any order of foreclosure of this Mortgage on behalf of the Borrower, the Borrower's estate and all persons beneficially interested therein.
