THIS ASSIGNMENT OF LEASES AND RENTS (this "Assignment" is made as of May 28, 1996, by Curtis Stephenson, a single person, having an address at 1447 South Spaulding Ave., Chicago, IL 80623 ("Assignor"), to CITYSCAPE MORTGAGE CORP., organized and existing under the laws of New York, having an address at 565 Taxter Road, Elmsford, New York 10523-2300 ("Assignee").

#### WITNESSETH:

Assignor, for good and valuable consideration, receipt whereof is hereby acknowledged, and intending to be legally bound hereby grants, transfers and assigns to Assignee the entire Assignor's interest in and to all leases and other agreements affecting the use, enjoyment or occupancy of all or any part of that certain lot or piece of land, more particularly described in Exhibit "A" annexed hereto and made a part hereof, together with the buildings, structures, futures, additions, enlargements, extensions, modifications, repairs, replacements and improvements now or hereafter located hereon (hereinafter collectively referred to as the "Mortgaged Property").

TOGETHER WITH all other leases and other agreements affecting the use, enjoyment or occupancy of the Mortgaged Property or any portion thereof now or hereafter made, together with any extension or renewal of the same, this Assignment of other present and future leases and present and future agreements and any extension or renewal of same (hereinafter collectively referred to as the "Leases") being effective without further or supplemental assignment.

TOGETHER WITH any end all rights against any guaranter of any lessee's performance under any of the Leases; and

TOGETHER WITH all rents, income, issues and profits arising from the Leases and together with all rents, income, issues and profits (including all without gas or other mineral royalties and bonuses) from the use, enjoyment and occupancy of the Mortgaged Property (hereinafter collectively referred to as the "Rents").

THIS ASSIGNMENT is made in consideration of that certain mortgage loan marke by Assignee to Assignor evidenced by that certain Mortgage Note made by Assignor to Assignee, dated the date hereof, in the principal sum of \$83,200.00 (the "Note"), and secured by that certain Mortgage and Security Agreement given by Assignor to Assignee, dated the date hereof, covering the Mortgaged Property and Intended to be duly recorded (the "Mortgage"). The principal sum, interest and all other sums due and payable under the Note and Mortgage are collectively referred to as the "Debt." The documents, other than this Assignment, the Note and the Mortgage, now or hereafter executed by Assignor and/or others and by or in favor of Assignee which wholly or partially secure or guarantee payment of the Debt, are hereinafter referred to as the "Other Security Documents."

ASSIGNOR WARRANTS that (a) Assignor is the sole owner of the entire lessor's interest in the Leases; (b) the Leases are valid and enforceable and have not been altered, modified or arrenned in any manner whatsoever except as therein set forth; (c) none of the Rents reserved in the Leases have been assigned or otherwise piedged or hypothecated; (d) none of the Rents have been collected for more than one (1) month in advance; (e) Assignor has full power and authority to execute and deliver this Agreement and the execution and delivery of this Assignment has been duly authorized and does not conflict with or constitute a catabit under any law, judicial order or other agreement affecting Assignor or the Mortgaged Property; (f) the improvements to the premises demised under the Leases have been completed and the tenants under the Leases have accepted the same and have taken possession of the same on a rent paying basis; and (g) there exist no offsets or defenses to the payment of any portion of the Rents.

ASSIGNOR COVENANTS with Assignee that Assignor (a) shall observe and perform all the obligations imposed upon the lessor under the Leases and shall not do or permit to be done anything to impair the value of the Leases as security for the Debt; (b) shall promptly send copies to Assignee of all notices of default which Assignor shall send or receive thereunder; (c) shall enforce all of the terms, covenants and conditions

contained in the Leases and any guarantees thereof upon the part of the lessees and the guarantors thereunder to be observed or performed, short of termination thereof; (d) shall not collect any of the Rents more than one (1) month in advance; (e) shall not execute any other assignment of lessor's interest in the Leases or the Rents; (f) shall not alter, modify or change the terms of the Leases without the prior written consent of Assignee, or cancel or terminate the Leases or accept a surrender thereof or convey or transfer or suffer or permit a conveyance or transfer of the Mortgaged Property or of any interest therein so as to effect a merger of this estates and rights of, or a termination or diminution of the obligations of, lessees thereunder; (g) shall not alter, modify or change the terms of any guaranty of any of the Leases or cancel or terminate any such guaranty without the prior written consent of Assignee; (h) shall not consent to any assignment of or subletting under the Leases not in accordance with its terms, without the prior written consent of Assignee; and deliver at the request of Assignee all such further assurances, confirmations and assignments in connection with the Mortgaged Property as Assignee shall from time to time require.

ASSIGNOR FURTHER COVENANTS with Assignee that (a) all Leases shall be written on the standard form of lease which has been approved by Assignee; (b) upon request, Assignor shall furnish Assignee with executed copies of pill-leases; (c) no material changes may be made to the Assignee-approved standard lease without the prior written consent of Assignee; (d) in addition, all renewals of Leases and all proposed leases shall provide for rental raise comparable to existing local market rates and shall be arms-length transactions; (e) all proposed leases which (i) are on the same form of lease which has been approved by Assignee, (ii) are the result of an arms-length transaction, (iii) which provide for rental rates comparable to existing market rates, and (iv) do not contain any terms which would materially affect Assignee's rights under the Mortgage, the Note, the Other Security Documents or this Assignment, shall riot be subject to the prior approval of Assignee; and (f) all Leases shall provide that they are subordinate to the rior gage and that the lessees agree to attorn to Assignee.

THIS ASSIGNMENT is made on the inliming terms, covenants and conditions:

#### GENERAL PROVISIONS

- Present Assignment. Assignor does hereb / absolutely and unconditionally assign to Assignee Assignor's right, title and interest in all current and future Leases and Rents, it being intended by Assignor that this assignment constitutes a present, absolute assignment and not an assignment for additional security only. Such assignment to Assignee shall not be construed to bind Assignce to the performance of any of the covenents, conditions and provisions contained in any such Lease of otherwise impose any obligation upon Assignee. Assignor agrees to execute and deliver to Assignee such additional instruments, in form and substance satisfactory to Assignee, as may hereafter be requested by Assignee to further evidence and confirm such assignment. Nevertheless, subject to the terms of this paragraph 1, Assignee grants to Assignor a revocable license to operate and manage the Mortgaged Property and to collect the Ronts. Assignor shall hold the Rents, or a portion thereof sufficient to discharge all current sums due on the Debt in trust for the benefit of Assignee for use in the payment of such sums. Upon an Event of Default (as defined in the Mortgage), the license granted to Assignor herein may be revoked, and Assignee shall immediately be entitled to possession of all Rents, whether or not Assignee enters upon or takes control of the Mortgaged Propurty. Assignee is hereby granted and essigned by Assignor the right, at its option, upon revocation of the license granted herein, to enter upon the Mortgaged Property in person, by agent or by court-appointed receiver to collect the Rents. Any Rents collected after the revocation of the license may be applied toward payment of the Debt in such priority and proportions as Assignee in its discretion shall deem proper.
- 2. Remedies of Assignee. Upon or at any time after an Event of Default, Assignee may, at its option, without waiving such Event of Default, without notice and without regard to the adequacy of the security for the Debt, either in person or by agent, with or without bringing any action or proceeding, or by a receiver appointed by a court, take possession of the Mortgaged Property and have, hold, manage, lease and operate the Mortgaged Property on such terms and for such period of time as Assignee may deem proper and, either with or without taking possession of the Mortgaged Property, in its own name, demand, sue for or otherwise

collect and receive all Rents, including those past due and unpaid with full power to make from time to time all ulterations, renovations, repairs or replacements thereto or thereof as may seem proper to Assignee and may apply the Rents to the payment of the following in such order and proportion as Assignee in its sole discretion may determine, any law, custom or use to the contrary notwithstanding: (a) all expenses of managing and security the Mortgaged Property, including, without being limited thereto, the sataries, fees and wages of a managing agent and such other employees or agents as Assignce may deem necessary or desirable and all expenses of operating and maintaining the Mortgaged Property, including, without being limited thereto, all taxes, charges, claims, assessments, water charges, sewer rents and any other liens, and premiums for all insurance which Assignee may deem necessary or desirable, and the cost of all alterations, renovations, repairs or replacements, and all expenses incident to taking and retaining possession of the Mortgaged Property; and (b) the Debt, together with all costs and attorneys' fees, in addition to the rights which Assignee may have herein, upon the occurrence of an Event of Default, Assignee, at its option, may either require Assignor to pay monthly in sixtnee to Assignee, or any receiver appointed to collect the Rents, the fair and reasonable rental value for the use and occupation of such part of the Mortgaged Property as may be in possession of Assignor or may require Assigner to vacate and surrender possession of the Mortgaged Property to Assignee or to such receiver and, in derruit thereof, Assignor may be evicted by summary proceedings or otherwise. For purposes of this paragraph 2, As a nor grants to Assignee its irrevocable power of attorney, coupled with an interest, to take any and all of the eforementioned actions and any or all other actions designated by Assignee for the proper management and preservation of the Mortgaged Property. The exercise by Assignee of the option granted it in this paragraph 2 and the collection of the Rents and the application thereof as herein provided shall not be considered a waiver of hy default by Assignor under the Note, the Mortgage, the Leases, this Assignment or the Other Security Documents.

- No Liability of Assigner. Assignee shall not be liable for any loss sustained by Assignor resulting from Assignee's failure to let the Mortgaged Property after an Event of Default or from any other act or omission of Assignee in managing the Mortgaged Property after default unless such loss is caused by the willful misconduct and bad faith of Assignee. Assignee shall not be obligated to perform or discharge any obligation, duty or liability under the Leases or under or by reason of this Assignment and Assignor shall, and hereby agrees, to indemnify Assignee for, and to hold Assignee harmless from, any and all liability, loss or damage which may or might be incurred under the Leases or under or by reason of this Assignment and from any and all claims and demands whatsoever, including the defends of any such claims or demands which may be asserted against Assignee by reason of any alleged obligations and undertakings on its part to perform or discharge any of the terms, covenants or agreements contained in the Leases. Should Assignee incur any such Hability, the amount thereof, including costs, expenses and reasonable Littorieys' fees, shall be secured hereby and by the Mortgage and the Other Security Documents and Assignor shall reimburse Assignee therefor immediately upon demand and upon the failure of Assignor so to do, Assignor may, at its option, declare all sums secured hereiny and the Mortgage and the Other Security Documents immediately due and payable and all such costs, expanses and attorneys' fees incurred by Assignee shall bear into est at the Note rate. This Assignment shall not operate to place any obligation or liability for the control, care, mer.agement or repair of the Mortgaged Property upon Assignee, nor for the carrying out of any of the terms and conditions of the Lease; nor shall it operate to make Assignee responsible or liable for any waste committed on the Morigaged Property by the tenants or any other parties, or for any dangerous or defective condition of the montagand Property, including, without limitation, the presence of any Hazardous Materials (as defined in the Mortgage), or for any negligence in the management, upkeep, repair or control of the Mortgaged Property resulting in loss or injury or death to any tenant, licensee, employee or stranger.
- 4. <u>Notices to Lessess.</u> Assignor thereby authorizes and directs the lessees named in the Lesses or any other or future lessees or occupants of the Mortgaged Property upon receipt from Assignee of written notice to the effect that Assignee is then the holder of the Mortgage and that a default exists litereunder or under this Assignment, the Note or the Other Security Documents to pay over to Assignee all Rents and to continue so to do until otherwise notified by Assignee.
  - 5. Other Security. Assignee may take or release other security for the payment of the Debt, may

release any party primarily or secondarily liable therefor and may apply any other security held by it to the reduction or satisfaction of the Debt without prejudice to any of its rights under this Assignment.

- 6. Other Remedies. Nothing contained in this Agreement and no act done or omitted by Assignee pursuant to the power and rights granted to Assignee hereunder shall be deemed to be a waiver by Assignee of its rights and remedies under the Note, the Mortgage, or the Other Security Documents and this Assignment is made and accepted without prejudice to any of the rights and remedies possessed by Assignee under the terms thereof. The right of Assignee to collect the Debt and to enforce any other security therefor held by it may be exercised by Assignee either prior to, simultaneously with, or subsequent to any action taken by it hereunder.
- 7. No Mortgagee in Possession. Nothing herein contained shall be construed as constituting Assignee a "mortgagee in possession" in the absence of the taking of actual possession of the Mortgaged Property by Assignee. In the exercise of the powers herein granted Assignee, no liability shall be asserted or enforced against Assignee, all such liability being expressly waived and released by Assignor.
- 8. Conflict of Terms. In case of any conflict between the terms of this Assignment and the terms of the Mortgage, the forms of the Mortgage shall prevail.
- 9. <u>No Oral Change.</u> This Assignment and any provisions hereof may not be modified, amended, waived, extended, changed, discharged or terminated urally, or by any act or failure to act on the part of Assigner or Assignee, but only no agreement in writing signed by the party against whom the enforcement of any modification, amendment, waiver, extension, change, discharge or termination is sought.
- specifically provided herein, words used in this Assignment may be used interchangeably in singular or plural form and the word "Assignor" shall mean "such Assignor and any subsequent owner or owners of the Mortgaged Property or any part thereof or interest therein," the word "Assignee" shall mean "Assignee and its successors and any subsequent holder of the Note" the word "Note" shall mean "the Note and any other evidence of indebtedness secured by the Mortgage," the word "Person" shall include an individual, corporation, partnership, trust, unincorporated association, government governmental authority, and any other entity, the word "Mortgaged Property" shall include any portion of the Note with interest thereon as provided in the Note and the word "Debt" shall mean the principal balance of the Note with interest thereon as provided in the Note and the Mortgage and all other sums owing pursuant to the Note, the Mortgage, this Assignment and the Other Socurity Documents; whenever the context may require, any primouns used herein shall include the corresponding masculine, feminine or neuter forms, and the singular form of nouns and pronouns shall include the plural and vice versa.
- Non-Waiver. The failure of Assignee to insist upon strict performance of any term hereof shall not be deemed to be a waiver of any term of this Assignment. Assignor shall not be relieved of Assignor's obligations hereunder by reason of (i) failure of Assignee to comply with any request of Assignor or any other party to take any action to enforce any of the provisions hereof or of the Mortgage, the Mute or the Other Security Documents, (ii) the release regardless of consideration, of the whole or any part or the Mortgaged Property, or (iii) any egreement or stipulation by Assignee extending the time of payment or otherwise modifying or supplementing the terms of this Assignment, the Note, the Mortgage or the Other Security Documents. Assignee may resort for the payment of the Debt to any other security held by Assignee in such order and manner as Assignee, in its discretion, may elect. Assignee may take any action to recover the Debt, or any portion thereof, or to enforce any covenant hereof without prejudice to the right of Assignee thereafter to enforce its rights under this Assignment. The rights of Assignee under this Assignment shall be separate, distinct and cumulative and none shall be given effect to the exclusion of the others. No act of Assignee shall be construed as an election to proceed under any one provision herein to the exclusion of any other provision.
- 12. <u>Inapplicable Provisions</u>. If any term, covenant or condition of this Assignment is held to be Invalid, illegal or unenforceable in any respect, this Assignment shall be construed without such provision.

- 13. <u>Duplicate Originals</u>. This Assignment may be executed in any number of duplicate originals and each such duplicate original shall be deemed to be an original.
- 14. <u>Governing Law.</u> This Assignment shall be governed and construed in accordance with the laws of the State of Illinois.
- 15. <u>Termination of Assignment</u>. Upon payment in full of the Debt and the delivery and recording of a satisfaction or discharge of the Mortgage duly executed by Assignee, this Assignment shall become and be void and of no effect.

THIS ASSIGNMENT, together with the covenants and warranties therein contained, shall insure to the benefit of Assignee and any subsequent holder of the Mortgage and shall be binding upon Assignor, his heirs, executors, administrators, successors and assigns and any subsequent owner of the Mortgaged Property.
