ATTORNMENT, SUBORDINATION AND NONDISTURBANCE AGREEMENT -

This Agreement is dated as or 44 30, 1996 and is made by and between SAF-T-GARD INTERNATIONAL, INC. ("Tonant") and LASALLE BANK NI ("Lendor").

EBBAMBLE

Pursuant to that cerinia Lease more fully described on Exhibit B attached hereto (said lease, as amended, and as may from time to time be amended, modified, substituted, extended, renewed or restrict shall be referred to as the "Lease"). American National Bank & Trust Company of Chicago, not individually, but solely as successor trustee to First Chicago Bank of Ravenswood with dated 3/17/86 and known as Trust No. 25-7659 or through its beneficiary, N. R. Properties Joint Venture (collectively, the "Landlord"), the owner of the property more fully described on Exhibit "A" attached hereto ("Property"), leased to Tenant the pertion of the Property described in the Lease. Landlord has requested Lender to provide financing (the "Financing") from time to time to Landlord and to Tenant, which Financing shall be secured by the Property. Lender has percent to provide such Financing so long as, among other things, this Agreement is entered into by Tenant.

NOW, THEREFORE, in consideration of the foregoing, to induce Lender to provide the Financing to Landlord and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties mutually agree as follows:

- Representations Regarding Lease. Tenant represents and warrants to Lender that (a) Tenant is in possession of the Proporty; (b) except as described on Exhibit B hereto, there have been no changes, modifications, alterations or amendments to the Lease; (c) except as otherwise disclosed in writing to Lender, no default or event of default (howsoever such terms are defined) exists under the Lease; (d) all parties to the Lease are in full compliance with the terms and provisions of the Lease; (e) all rent and other payments required to be paid by Tenant under the Lease as of the date of this Agreement have been paid in full; and (f) Tenant has no offsets or defenses to Tenant's performance under the Lease.
- 2. <u>Attornment.</u> Tenant covenants and agrees to attorn to Lender or any other purchaser at any forcelosure sale of the Property as its new landlord and upon such event the Lease shall continue in full force and effect as a direct lease between the Tenant and Lender or such other person, upon all terms, covenants, conditions and agreements set forth in the Lease; <u>provided</u>, <u>however</u>, that in no event shall Lender or such third person be (a)

tiable for any act or omission of the Landlord; (b) subject to any offsets or deficiencies which the Tenant might be entitled to assert against the Landlord; (c) bound by any payment of rent or additional rent made by the Tenant to the Landlord for more than one month in advance; or (d) bound by any amendment or material modification of the Lease after the date of this Agreement made without the consent of Lender.

- 3. Subordination of Lease. Tenant covenants and agrees that all of Tenant's right, title and interest in and under the Lease is and shall be subordinated to the lien or interest of Lender in and to the Property, and to all right, title and interest granted to Lender in and to the Property, in the same manner as if the Lease had been executed after execution, delivery and recording of Lender's interest in the Property.
- 4. Nondisturbance. Lender covenants and agrees that in the event that Lender or any other person exercises any of its rights, powers or remedies pursuant to any agreement, instrument or document relating to the Financing with respect to the Property, and Lender or any other person acquires title to the Property pursuant to the exercise of any such right, power or remedy, and provided that the Tenant is not then in default under the Lease, then Tenant's leavehold shall not be disturbed by Londer's or any third parties' exercise of any of such rights, powers or remedies.
- 5. American Modifications. This Agreement may not be modified other than by agreement in writing signed by Lender and Tenant, or by their respective successors in interest.
- 6. Binding Agreement. This Agreement shall inure to the benefit of and shall be binding upon Lender and its successors and assigns, and be binding upon Tenant and its successors and assigns.
- 7. Counterparts. This Agreement may be executed in any number of counterparts, each of which counterparts, once executed and delivered, shall be deemed to be an original and all of which counterparts taken together, shall constitute but one and the same Agreement.
- 5. Governing Laws. This Agreement shall be deemed to be a contract made under the laws of the State of Illinois and for all purposes shall be construed in a cordance with the internal laws, and not the conflict of laws provisions, of the State of Illinois.
