1996, between Lender and Grantor with a maximum cradit limit of \$60,000.00, together with all renewals of, extensions of, modifications of, refinancings of, consolidations of, and substitutions for the Cradit Agreement. The maturity date of the obligations secured by this Mortgage is May 9, 2011. The interest rate under the Cradit Agreement is a variable interest rate based upon an index. The index currently is 8,250% per annum. The interest rate to be applied to the outstanding account balance shall be at a rate 1,600 percentage points above the index, subject however to the following maximum rate. Under no circumstances shall the interest rate be more than the lesser of 19,800% per annum or the maximum rate allowed by applicable law.

Existing Indebtedness. The words "Existing Indebtedness" mean the indebtedness described below in the Existing Indebtedness section of this Mortgage.

Crantor. The word "Grantor" means DEAN A. VITALE and CATHY J. VITALE. The Grantor is the morngagor under this Mortgage.

Guarantor. The 'void "Guarantor" means and includes without limitation, each and all of the guarantors, sureties, and accoming lation parties in connection with the Indebtedness.

The word "Indebtedness" means all principal and interest payable under the Cradit Indubtedness. Agreement and any amounts expended or advanced by Lender to discharge obligations of Grantor or expenses incurred by Lender to enforce obligations of Grantor under this Mortgage, together with interest on such amounts as provided in this Mortgage. Specifically, without limitation, this Mortgage securas a revolving line of credit and shall secure not only the amount which Lender has presently advanced to Grantor under the Credit Agraement, but also any luture amounts which Lender may advance to Grantor under the Crodit Agreement within twenty (20) years from the date of this Mortgage to the same extent as if such future advance were made as of the date of the execution of this Mortgage. The revolving line of credit obligates Lender to make advances to Grantor so long as Grantor compiles with all the terms of the Credit Aureement and Reluted Documents. Ntortgage. The word "Mortgage" means this Mortgage between Grantor and Lender, and includes without limitation all assignments and security interest provisions relating to the Personal Property and Bents. At no time shall the principal amount of Indebtedness secured by the Mortgage, not including sums advanced to protect the security of the Mortgage, exceed the Credit Limit of \$60,000.00.

Personal Property. POSSESSION AND MAINTENANCE OF THE PROPERTY. Grantor agrees that Grantor's possession and use of withe Property shall be governed by the following provisions:

Duty to Maintein. Grantor shall maintain the Property in good condition and promptly perform all repairs, replacements, and maintenance necessary to preserve its value.

DUE ON SALE - CONSENT BY LENDER. Lender may, at its option, declare immediately due and payable all surns secured by this Morceage upon the sale or transfer, without the Lender's prior written consent, of all or any part of the Real Property, or any interest in the Real Property. A "sale or transfer" means the conveyance of Real Property or any right, this or interest therein; whether legal, beneficial or equitable; whether voluntary or involuntions: whether by out with sale, deed, installment sale contract, land contract, contract for deed, leasehold interest with a term greater than three (3) years, lease-option contract, or by sule, assignment, or transfer of any beneficial interest in or to any land trust holding title to the Real Property, or by any other method of conveyance of Real Property interest. If any Grantor is a corporation, partnership or limited liability company, "sale or transfer' siso includes any chango is extraorship of more than twenty-five percent (25%) of the voting stock, partnership interests or limited liability company interests, as the case may be, of Granter. However, this option shall not be exercised by Lender if such exercise is prohibited by federal lnw or by illinois lnw.

TAXES AND LIENS. The following provisions talating to the texas and liens on the Property are a part of this Mortgage.

Payment. Grantor shall pay when due (and in the overts prior to delinquency) all taxes, payroll taxes, special taxes, assessments, water charges and sewer service charges levied against or on account of the Property, and shall pay when due all claims for work done on or for services randered or material furnished to the Property. Granter shall maintain the Property Iree of all liens having priority over or equal to the interest of Londer under this Mortgage, except for the lieu of taxes and assessments not due.

PROPERTY DANIAGE INSURANCE. The following provisions relating to insuring the Property are a part of this Mortgage.

Maintenance of insurance. Grantor shall produce and maintain policies of fire insurance with standard extended coverage endorsements on a replacement basis to the full insurable value covering all improvements on the Real Property in an amount sufficient to avoid application of any coinsurance clause, and with a standard mortgage clause in favor of Landar. Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Londar. Grantor shall deliver to Londar certificates of coverage from each insurer containing a stipulation that coverage will not be cancelled and disclaimer of the insurer's hability for failure to give such notice. Each insurer or policy also shall include an endorsement providing that coverage in favor of Lender will not be impaired in any way by any act, or isolance default of Grantor or any other person. Should the Real Property at any time freeches located in a read designated by the Director of the Federal Emergency Management Agency as a species flood hazart area, Grantor agrees to obtain and maintain Federal Flood insurance, to the extent such insurance is required by Grantor agrees to obtain and maintain Federal Flood Insurance, to the extent such insurance is required by Lander and is or becomes evailable, for the term of the loan and for the full unpaid principal balance of the loan, or the maximum limit of coverage that is available, whichever is less.

Whether or not Lender's security is impaired, Lender may, at its election, apply the proceeds to the reduction of the Indahtedness, payment of any lien affecting the Property, or the restoration and repair of the Property

EXPENDITURES BY LENDER. If Grantor falls to comply with any provision of this Mortgage, including any obligation to maintain Existing Indubtedness in good standing as required below, or if any action or proceeding is obligation to maintain Existing Indebtedness in good standing as required below, or if any action or proceeding is commenced that would materially affect Lender's interests in the Property, Lender on Grantor's behalf may, but shall not be required to, take any action that Lender deems appropriate. Any amount that Lender expends in so doing will bette interest at the rate provided for in the Credit Agreement from the date incurred or paid by Lender to the date of repayment by Grantor. All such expenses, at Lender's option, will (a) be payable on demand, (b) be added to the balance of the credit line and be apportioned among and be payable with any installment payments to become due during either (i) the term of any applicable insurance policy, or (ii) the remaining term of the Credit Agreement, or (c) be treated as a balloon payment which will be due and payable at the Credit Agreement's maturity. This Mortgage also will secure payment which will be due and payable at the Credit Agreement's maturity. This Mortgage also will secure payment of these amounts. The rights provided for in this paragraph shall be in addition to any other rights or any remedies to which Lender may be antitled on account of the default. WARRANTY: DEFENSE OF TITLE.

Title. Grantor warrants that: (a) Grantor holds good and marketable title of record to the Real Property in fee simple, free and clear of all liens and encumbrances other than those set forth in the Real Property description or in the Existing Indebtedness section below or in any title insurance policy, title report, or final title opinion issued in favor of, and accepted by, Lender in connection with this Mortgage, and (b) Granfor has the full right, power, and authority to execute and deliver this Mortgage to Lender.

Defense of Title. Subject to the exception in the paragraph above, Granter warrants and will forever defend the title to the Property against the lawful claims of all persons.

No Other Liens. EXISTING INDEBTEDNESS. The following provisions concerning existing indebtedness (the "Existing Indebtedness") are a part of this Mortgage.

Existing Lien. The lien of this Mortgage securing the Indebtedness may be secondary and inferior to an existing lien. Grantor expressly covenants and agrees to pay, or see to the payment of, the Existing Indebtedness and to prevent any default on such indebtedness, any default under the instruments evidencing such indebtedness, or any default under any security documents for such indebtedness.

FULL PERFORMANCE. If Granter pays all the Indebtedness when due, terminates the credit line account, and otherwise performs all the obligations imposed upon Granter under this Mortgage, Lender shall execute and deliver to Granter a suitable satisfaction of this Mortgage and suitable statements of termination of any financing statement on file evidencing Lender's security interest in the Rents and the Personal Property. Granter will pay, if permitted by applicable law, any reasonable termination fee as determined by Lender from time to time. If, however, payment is made by Granter, whether voluntarily or otherwise, or by guaranter or by any third party, on the Indebtedness and thereafter Lender is friged to remit the amount of that payment (a) to Granter's trustee in bankruptcy or to any similar person under any federal or state bankruptcy law or law for the relief of debtors, by reason of any judgment, decree or order of any court or administrative body having jurisdiction over Lender or any of Lender's property, or (c) by reason of any settlement or comprise of any claim made by lender with any claimant (including without limitation Granter), the Indebtedness shall be considered unpaid for the purpose of enforcement of this Mortgage and this Mortgage are of any note or other instrument or agreement evidencing the Indebtedness and the Property will continue to secure the amount repaid or recovered agreement evidencing the Indebtedness and the Property will continue to secure the amount repaid or recovered to the same extent as if that amount never had been originally acceived by Lender, and Grantor shall be bound by any judgment, decree, order, settlement or compromise relating to the Indebtedness or to this Mortgage.

DEFAULT. UCC Remedies. With respect to all or any part of the Personal Property, Lander shall have all the rights and remedies of a secured party under the Uniform Commercial Code.

Judicial Foreclosure. Lender may obtain a judicial decree foreclosing Grantor's interest in all or any part of the Property.

Deficiency Judgment. If permitted by applicable law, Lender may obtain a judgment for any deficiency remaining in the inductedness due to Lender after application of all amounts received from the exercise of the rights provided in this section.

Other Remedies. Lender shall have all other rights and remedies provided in this Mortgage or the Credit Agreement or available at law or in equity.
