FLEXEQUITY ACCOUNT MORTGAGE

THIS FLEXEQUITY MORTGAGE is made this 6th day of June 1996 by and between Steven J. Mason and Karen M. Mason, Husband and Wife

(herein "Borrower") and GLENVIEW STATE BANK an Illinois Corporation, whose address is 800 Waukegan Road, Glenview, Illinois 60025 (herein "Lender"). (216012) RE TITLE DEPT/CSA PG 812-11

Whereas, Borrower is indebted to Lender under that certain FlexEquity Account Promissory Note dated June 6, 1996 (herein "Note") with a credit limit of Ninety Thousand Dollars and no / 100 dollars (\$ 90,000.00) (a minimum amount of \$10,000.00) of which an initial advance of xxxxxxxxxxxxxxxxxxxxxxxxxxxxxxxx (\$ XXX) has been made and against which Borrower may draw and Lender is obligated to make advances from time to time to the full amount thereof. Repayments of sums advanced from time to time will replenish the credit limit pro tanto so that the total amount that may be lent under the Note may exceed the credit limit thereof but not at any one time. The Note provides for monthly installments of interest or, if Borrower has elected to take any advance as a term loan, of principal and interest, at the rates set forth in the Note, with the principal balance of the indebtedness, if not sooner paid or required to be paid, due and payable five (5) years from the date hereof.

Borrower, in consideration of the indebtedness herein recited, does hereby mortgage, grant, warrant and convey (unless Borrower is a Trust, in which event Borrower does hereby mortgage, grant, quitclaim and convey) unto Lender and its successors and assigns, the following described property located in the County of Cook, State of Illinois:

2. FUNDS FOR TAXES AND INSURANCE. Borrower covenants that Borrower is the lawful owner of the estate in land hereby conveyed and has the right to grant, convey and mortgage the property, and that the Property is unencumbered except for that certain mortgage or Deed of Trust in favor of Curtis D. Moore dated May 22, 1993 and recorded May 22, 1993 at page 1993, Book 22, County of Marion, Indiana. Borrower agrees to pay all taxes, assessments, insurance premiums, and other charges which may be levied against the property or any part thereof, or change in any way the condition of title of the property of any part thereof.

The funds shall be held in an institution the deposits or accounts of which are insured or guaranteed by a Federal or State Agency (including Lender if Lender is such an institution). Any such waiver shall apply only to the extent specifically set forth in the writing. A waiver as to one event shall not be construed as continuing or as a waiver as to any other event.
