TOGETHER with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances and rents, all of which shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are hereinafter referred to as the "Property".

22. EFFECT OF THIS RIDER.

Borrower understands that this Rider is a part of this Mortgage, and that it may change or add to any promises or agreements contained in this Mortgage or any other Rider to this Mortgage. Whenever the terms, conditions and promises contained in the printed notion of, or any other Rider to, this Mortgage differ or are in conflict with this Rider, the provisions of this Rider will control.

23. SUMS SECURED

The 'indebtedness' and 'sums' referred to in the hird unnumbered paragraph of this Mortgage and referred to elsewhere in this Mortgage shall be defined as 'S ims Secured' and shall further include all sums payable under any of the provisions of this Mortgage.
