Trustee or the holders of the note may, but need not, make any payment or parform any act have independent required of Mortgage, in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on any form any tax sale or fordelture affecting said premises or contest any tax or assessment. - 7. When the indebredness hereby secured shall become due whather by the trans) of the note described on page one or by acceleration or otherwise, holders of the note or Trustes shall have the right to foreclose the lien hereof and also shall have all other rights provided by the laws of Illinois for the enforcement of a mortgage debt. In any sale of foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and expers which may be paid or incurred by or on behalf of Trustee or holders of the note for attorneys' fees, Trustee's fees, appraiser's fees, outley, for documentary and expert evidence, stanographers' charges, publication coers and coers (which may be astimated as so items to be intended after entry of the decree) of procuring all such abstracts of title, title searches and examinations, guarantee policies. The proceeds of any foreclosure sale of the premises shall be distributed and applied in the following order of priority: First, on account of all costs and expenses incident to the foreclosure proceedings, including all such items as are mentioned in the preceding paragraph hereof; second, all other items which under the terms hereof constitute secured indebtedness additional to that evidenced by the note hereby secured, with interest thereon as hereis provided; third, all principal and interest remaining unpaids fourth, any overplus to Morangors, their heirs, legal sepresentatives or assigns, as their rights may appear.

- 11. Trustee or the holders of the note thall have the right to inspect the premises at all reasonable times and access thereto shall be permissed for that purpose.
- 12. Trustee has no duty to examine the title, location, existence, or condition of the premises, nor shall Trustee be obligated to record this Trust Dead or to exercise any power herein given unless expressly obligated by the terms hereof, not be liable for any sees or omissions hereogener, except in case of his own gross negligence or misconduct or that of the agents or employees of Trustee, and he may require indemnities extinfactory to him before exercising any power herein given.
- 13. Trustee shall release this Trust Deed and the lien thereof by proper instrument upon presentation of satisfactory evidence that all indebtodness secured by this Trust Deed has been fully paid; and Trustee may execute and deliver a release hereof to and at the request of any person who should inher before or after manualty thereof, produce and exhibit to Trustee the principal note, suppresenting that all indebtodness hereby actured has been paid, which representation Trustee may accept as true without inquiry.
