FLEXEQUITY ACCOUNT MORTGAGE

THIS FLEXEQUITY MORTGAGE is made this 7th day of June 1996 by and between Richard M. Venema and Wayne A. Buhr,

(herein "Borrower") and GLENVIEW STATE BANK, an Illinois Corporation, whose address is 800 Waukegan Road, Glenview, Illinois 60025 (herein "Lender"). Both Single Mtns

Whereas, Borrower is indebted to Lender under that certain FlexEquity Account Promissory Note dated June 7, 1996 (herein "Note") with a credit limit of Fifty Thousand Dollars and no/100 dollars (\$ 50,000.00) (a minimum amount of \$10,000.00) of which an initial advance of xxxxxxxxxxxxxxxxxxxxxxxxxxxxxxxxx (\$ xx.) has been made and against which Borrower may draw and Lender is obligated to make advances from time to time to the full amount thereof. Repayments of sums advanced from time to time will replenish the credit limit pro tanto so that the total amount that may be lent under the Note may exceed the credit limit thereof but not at any one time. The Note provides for monthly installments of interest or, if Borrower has elected to take any advance as a term loan, of principal and interest, at the rates set forth in the Note, with the principal balance of the indebtedness, if not sooner paid or required to be paid, due and payable five (5) years from the date hereof.

Borrower, in consideration of the indebtedness herein recited, does hereby mortgage, grant, warrant and convey (unless Borrower is a Trust, in which event Borrower does hereby mortgage, grant, quitclaim and convey) unto Lender and its successors and assigns, the following described property located in the County of Cook, State of Illinois:

2. FUNDS FOR TAXES AND INSURANCE. Subject to applicable law or to a waiver by Lender, Borrower shall pay to Lender on the day monthly installments of interest would be payable under the Note, until the Note is paid in full, a sum (herein "Funds") equal to one-twelfth of the yearly taxes and assessments which may attain priority over this Mortgagor, and ground rents on the Property if any, plus one-twelfth of yearly premium installments for hazard insurance.

1. PAYMENT AND COMPLIANCE WITH NOTE; APPROPRIATION OF PAYMENTS; BORROWER SHALL PAY WHEN DUE THE PRINCIPAL AND INTEREST ON THE INDEBTEDNESS EVIDENCED BY THE NOTE TOGETHER WITH ANY INTEREST OR CHARGES IMPOSED UNDER THE NOTE, AND THE PRINCIPAL AND INTEREST ON ANY FUTURE ADVANCES (AS DEFINED IN PARAGRAPH 27 BELOW) SECURED BY THIS MORTGAGE. UNLESS APPLICABLE LAW REQUIRES OTHERWISE, ALL PAYMENTS RECEIVED UNDER THE NOTE AND THIS MORTGAGE SHALL BE APPLIED BY LENDER FIRST IN PAYMENT OF ANY ADDITIONAL SUMS OWING TO LENDER PURSUANT TO THE PROVISIONS OF THE CREDIT DOCUMENTS, WHETHER AS ADVANCES, ATTORNEY'S FEES (TO THE EXTENT PERMITTED BY LAW) DELINQUENCY COSTS AND EXPENSES OF EXERCISING RIGHTS AND REMEDIES GRANTED UNDER THE CREDIT DOCUMENTS; SECOND, TO THE PAYMENT OF ANY SUMS DUE UNDER PARAGRAPH 2 HEREAT; THIRD, TO THE PAYMENT OF INTEREST ON THE PAYMENT OF PRINCIPAL OF THE NOTE; AND THEN TO INTEREST AND PRINCIPAL ON ANY FUTURE ADVANCES.

Covenants. Borrower and Lender covenant and agree as follows:

THIS MORTGAGE IS GIVEN TO SECURE: (i) the repayment of the indebtedness evidenced by the Note, (ii) the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this mortgage, and (iii) the performance of the covenants and agreements of Borrower contained herein and in the Note, and, if title to the property is held by a Trust, in the Flexequity Security Agreement ("the "Security Agreement") of the Note, the Security Agreement, and any and all instruments now or hereafter given to evidence or secure the indebtedness evidenced by the Note, are collectively referred to herein as the "Credit Documents". The Credit Documents constitute and this Mortgage permits and secures, future advances.

Borrower acknowledges that the Note calls for a variable interest rate, and that the Lender may, prior to the expiration of the term of the Note, cancel future advances therunder, reduce the amount of credit available, and/or require repayment of the outstanding balance under the Note.

Borrower covenants that Borrower is the lawful owner of the estate in land hereby conveyed and has the right to grant, convey and mortgage the property, and that the property is unencumbered except for that certain Mortgagor Deed of Trust in favor of xxxxxx dated xxxxxx and recorded/xxxxxx as Document No. xxxxxx in the Office of Deeds/Register of Titles, C. o. k. County, Illinois. Borrower (unless Borrower is a Trust) covenants that Borrower warrants and defend generally the title to the property against all claims and demands, subject to encumbrances of record. Borrower covenants that Borrower will neither take nor permit any action to partition or subdivide the property or otherwise change the legal description of the property or any part thereof, or change in any way the condition of title of the property of any part thereof.

1. USES AND BENEFITS: All improvements now or hereafter erected on the property in and to the rights of ways, streets, avenues and alleys adjoining the property, and rents (subject to the rights and authorities given herein to Lender to collect and apply such rents), royalties and minerals, gas rights, water rights, and water stock, insurance and replacement proceeds, and all fixtures now or hereafter attached to the property, all of which, including condensate, royalties now or hereafter attached to the property, shall be deemed to be and remain a part of the property covered by this mortgage; and of the foregoing, or the leasehold estate if this mortgage is on a leasehold) are hereinafter referred to as the "Property", as to any property which does not constitute a fixture (as such term is defined in the Uniform Commercial Code), this Mortgage is deemed to be, as well, a Security Agreement under the UCC for the purpose of creating a security interest in such property, which Borrower hereby grants to Lender as Secured Party (as such term is defined in the UCC); and not without giving notice to the contrary herein, the Property shall include all of Borrower's right, title, and interest in and to the real property described above whether such right, title, and interest acquired before or after execution of this Mortgage specifically, and without limitation of the foregoing, it this Mortgage acquires a fee interest in the real property, the lien of this Mortgage shall by Borrower, and Borrower subsequently acquires a fee interest in the real property, the lien of this Mortgage shall set forth herein.

Insurance, plus one-twelfth of yearly premium installments for mortgage insurance, if any, all as reasonably estimated initially and from time to time by Lender on the basis of assessments and bills and reasonable estimates thereof.

The funds shall be held in an institution the deposits or accounts of which are insured or guaranteed by a Federal or State Agency (including Lender if Lender is such an institution). Lender shall apply the Funds to pay said taxes, assessments, insurance premiums and ground rents. Lender may not charge for so holding and applying the Funds, analyzing said account or verifying and compiling said assessments and bills, unless Lender pays Borrower interest on the Funds and applicable law permits Lender to make such a charge. Borrower and Lender may agree in writing at the time of execution of the language that interest on the Funds shall be paid to Borrower, and unless such agreement be made or applicable law requires such interest to be paid, Lender shall not be required to pay Borrower any interest or earnings on the Funds. Lender shall give to Borrower, without charge, an annual accounting of the Funds showing credits and debits to the Funds and the purpose for which each debit to the Funds was made. The Funds, if any, are pledged as additional security for the sums secured by this Mortgage, and are held by Lender as a creditor and not as a trustee.

If the amount of the Funds held by Lender, together with the future monthly installments of Funds payable prior to the due dates of taxes, assessments, insurance premiums and ground rents, shall exceed the amount required to pay said taxes, assessments, insurance premiums and ground rents as they fall due, such excess shall be, at Borrower's option, either promptly repaid to Borrower or credited to Borrower on subsequent monthly installments of Funds. If the amount of Funds held by Lender shall not be sufficient to pay taxes, assessments, insurance premiums and ground rents as they fall due, Borrower shall pay to Lender any amount necessary to make up the deficiency within thirty (30) days from the date notice is mailed by Lender to Borrower requesting payment thereof.

Neither Lender nor any institution designated by Lender to hold the Funds shall be liable for any failure to make the payments of insurance premiums, taxes or ground rents unless Borrower, while not in default hereunder, shall have requested Lender or such institution to make application of the Funds to the payment of the applicable insurance premiums, taxes or ground rents, accompanied by the bills for such insurance premiums, taxes or ground rents. Notwithstanding the foregoing Lender may, at its option, make or cause such institution to make any such application of the Funds without any direction or request to do so by Borrower.

Upon payment in full of all sums secured by this Mortgage, Lender shall promptly refund to Borrower any funds held by Lender. If under Paragraph 17 hereof the Property is sold or the Property is otherwise acquired by Lender, Lender shall apply, no later than immediately prior to the sale of the Property or its acquisition by Lender, any Funds held by Lender at the time of application as a credit against the sums secured by this Mortgage.

3. PRIOR ENCUMBRANCE; CHARGES; LIENS. Borrower shall fully and timely perform all of Borrower's obligations under any mortgage, deed of trust or other security agreement with a lien which has or appears to have any priority over this Mortgage, including Borrower's covenants to make any payments when due. A default under any prior mortgage or deed of trust or other security agreement with a lien which has or appears to have any priority over this Mortgage may at the option of Lender be declared and deemed to be a default under this Mortgage but only if such default adversely affect Lender's security for the note of any rights of Lender in the security. Borrower shall pay all taxes, assessments and other charges, fines and impositions attributable to the Property which may attain a priority over this Mortgage, and leasehold payments or ground rents, if any, in the manner provided under Paragraph 2 hereof or, if not paid in such manner, by Borrower making payment, when due, directly to the payee thereof. Borrower shall promptly furnish to Lender all notices of amounts due under this paragraph, and in the event Borrower shall make payment directly, Borrower shall promptly furnish to Lender receipts evidencing such payments. Borrower shall promptly discharge any lien which may attain priority over this Mortgage (other than any prior first mortgage or deed of trust); provided, that Borrower shall not be required to discharge any such lien so long as Borrower shall agree in writing to the payment of the obligation secured by such lien in a manner acceptable to Lender or shall in good faith contest such lien by, or defend enforcement of such lien in, legal proceedings which operate to prevent the enforcement of the lien or forfeiture of the Property or any part thereof.

4. HAZARD INSURANCE. Borrower shall, at Borrower's cost keep the improvements now existing or hereafter erected on the Property insured against loss by fires, hazards included within the term "extended coverage and such other hazards (collectively agreed to as "Hazards" as Lender may require. Borrower shall maintain Hazard insurance for the entire term of the Note or such other periods as Lender may require and in an amount equal to the lesser of (a) the maximum insurable value of the Property or (b) the amount of the line of credit secured by this Mortgage plus the outstanding amount of any obligations secured in priority over this Mortgage, but in no event shall such amounts be less than the amount necessary to satisfy the co-insurance requirement contained in the insurance policy.

5. PLANNED INITIATIVE AND MAINTENANCE OF PROPERTY; LEASEHOLDS; CONDOMINIUMS; **PREREVIVAL AND AGREEMENTS, ORDINANCES, STATUTES, DECREES OR REGULATIONS, THAT MAY BE APPLICABLE TO THE PROPERTY IN COMPLIANCE WITH THIS MORTGAGE, AS IT IS RECORDED TOGETHER WITH THE COVENANTS AND AGREEMENTS OF THIS MORTGAGE AS IT IS RECORDED THEREON.**

Unless Lender and Borrower otherwise agree in writing, any such application of proceeds to principal shall not exceed or postpone the due date of the installments recited to in Paragraph 1 and 2 hereof or change the amount of such installments.

If under Paragraph 17 hereof the Property is acquired by Lender, all rights, title and interest of Borrower in and to any insurance policies and in and to the proceeds thereof, resulting from damage to the extent of the sums secured by this Mortgage immediately prior to acquisition shall become the property of Lender to the extent of the sums secured by this Mortgage immediately prior to such sale or acquisition.

If the Property is abandoned by Borrower or if Borrower fails to respond to a claim for insurance within thirty (30) calendar days from the date notice is mailed by Lender to Borrower that the insurance carrier offers to settle a claim for insurance benefits, Lender is irrevocably authorized to settle the claim and to collect and apply the insurance proceeds at Lender's sole option either to recoupment or repair the Property or to the sum secured by this Mortgage.

Subject to the rights and terms of any mortgagee, deed of trust or other security agreement with a hen which has or appears to have any priority over this Mortgage and unless Borrower and Lender otherwise agree in writing, trustee
proceeds shall be applied to restoration of the property damaged, provided such restoration or repair is
economically feasible and the security of this Mortgage is not thereby impaired. If such restoration or repair is
economically feasible and the security of this Mortgage is not thereby impaired, such restoration or repair is
economically feasible or in the security of this Mortgage would be impaired, the insurance proceeds shall be applied to
the sums secured by this Mortgage, with the excess, if any, paid to Bank or owner. Such application shall not cure or waive any
default under this Mortgage or invalidate any act done pursuant to such notice.

In the event of loss, Borrower shall give prompt notice to the insurance carrier and Lender may make proof of loss if not made promptly by Borrower.

Any amounts disbursed by Lender pursuant to this Paragraph 6, with interest thereon at the rate from time to time in effect under the Note for revolving credit advances, shall become additional indebtedness of Borrower secured by this Mortgage. Unless Borrower and Lender agree, in writing, to other terms of payment such amounts shall be payable upon notice from Lender to Borrower requesting payment therefor and if such are not paid within the time period set forth in such notice, such amounts may be charged by Lender as a draw on the Note. Nothing contained in this Paragraph 6 shall require Lender to incur any expense or take any action hereunder and any action taken shall not release Borrower from any obligation in this Mortgage.

7. **INSPECTION.** Lender may make or cause to be made reasonable entries upon and inspections of the Property, provided that, except in an emergency, Lender shall give Borrower notice prior to any such inspection specifying reasonable cause therefor related to Lender's interest in the Property.

8. **CONDAMNATION.** The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conveyance in lieu of condemnation, are hereby assigned and shall be paid to Lender subject to the terms of any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage. Borrower agrees to execute such further documents as may be required by the condemnation authority, to effectuate this paragraph. In the event of a total taking of the Property, the proceeds shall be applied to the sums secured by this Mortgage, with the excess, if any, paid to Borrower. In the event of a partial taking of the Property, unless Borrower and Lender otherwise agree in writing, there shall be applied to the sums secured by this Mortgage such proportion of the proceeds as is equal to that proportion which the amount of the sums secured by this Mortgage immediately prior to the date of taking bears to the fair market value of the Property immediately prior to the date of taking, with the balance of the proceeds paid to Borrower.

If the Property is abandoned by Borrower or if, after notice by Lender to Borrower that the condemnor offers to make an award or settle a claim for damages, Borrower fails to respond to Lender within thirty (30) days after the date such notice is mailed, Lender is authorized to collect and apply the proceeds, at Lender's option, either to restoration or repair of the Property or to the sums secured by this Mortgage.

Unless Lender and Borrower otherwise agree in writing, any such application of proceeds to principal shall not extend or postpone the due date of the installments referred to in Paragraph 1 and 2 hereof or change the amount of such installments.

9. **BORROWER NOT RELEASED; FORBEARANCE BY LENDER NOT A WAIVER.** Extension of the time for payment, acceptance by Lender of payments other than according to the terms of the Note, modification in payment terms of the sums secured by this Mortgage granted by Lender to any successor in interest of Borrower, or the waiver or failure to exercise any right granted herein or under the Credit Documents shall not operate to release in any manner the liability of the original Borrower, Borrower's successors in interest, or any guarantor or surety thereof, Lender shall not be required to commence proceedings against such successor or refuse to extend time for payment or otherwise modify payment terms of the sums secured by this Mortgage by reason of any demand made by the original Borrower and Borrower's successors in interest. Lender shall not be deemed, by any act of omission or commission, to have waived any of its rights or remedies hereunder unless such waiver is in writing and signed by Lender. Any such waiver shall apply only to the extent specifically set forth in the writing. A waiver as to one event shall not be construed as continuing or as a waiver as to any other event. The procurement of insurance or the payment of taxes, other liens or charges by Lender shall not be a waiver of Lender's right as otherwise provided in this Mortgage to accelerate the maturity of the indebtedness secured by this Mortgage in the event of Borrower's default under this Mortgage or the other Credit Documents.

Set forth below is a list of events which, upon the lapse of the applicable grace period, if any, shown particularly after such events, will constitute an Event of Default; (2) Borrower's failure to pay when due any amounts due under the Credit Documents (30 day grace period); (3) Borrower's conduct in or omission of material misrepresentation or concealment with the lack of credit, whether knowledge of any fraud or Borrower's credit application by Borrower in connection with the lack of credit, whether committed in or fraud or Borrower's material status and the transfer of Borrower's interest in the Property of the Collateral (as such term is defined in the Security Agreement) to someone who is a signer of all the Credit Documents, if any, and, as a result thereof, Lender's security for the Note or any rights of the Lender is such security adversely affected (no grace period); (4) Borrower's sale or transfer of, or promise to sell or transfer, all or any part of the Property or any interest therein, of any interest in the Collateral, whether voluntary or involuntary, without Lender's prior written consent (no grace period); (5)

A. An Event of Default will occur if Borrower fails to give notice to Lender of any of the Credit Documents and upon Borrower's failure to cure such breach and to provide Lender with evidence reasonably satisfactory to it of such cure, within the applicable grace period, if any. In each case, the grace period begins to run on the day after notice is given, and expires at 11:59 p.m., Central time, on the last day of the period. All grace periods are extended in calendar days, not business days. If there is no grace period applicable to a particular type of default, the Event of Default will be complete upon the giving of such notice. Such notice shall be given to Borrower in accordance with Paragraph 11 hereof and shall contain the following information: (1) the nature of Borrower's breach; (2) the applicable grace period, if any, during which such breach must be cured; and (3) whether failure to cure such breach within the specified grace period, if any, will result in acceleration of the sums secured by this Mortgage and the potential foreclosure of this Mortgage. The notice shall further inform Borrower of the rights, if any under applicable law, to reinstate the revolving line of credit under this Mortgage after acceleration.

EVENTS OF DEFAULT.

14. **REMEDIES CUMULATIVE.** Lender may exercise all of the rights and remedies provided in this Mortgage and in the Credit Documents, or which may be available to Lender by law, and all such rights and remedies shall be cumulative and concurrent, and may be pursued singularly, successively or together, at Lender's sole discretion, and may be exercised as often as occasion therefor shall occur.

12. GOVERNMENT LAW; SEVERABILITY. This Mortgage shall be governed by the laws of the State of Illinois, which laws shall also govern the construction, enforceability and interpretation of this Mortgage. The foregoing sentence shall not limit the applicability of federal law to this Mortgage. Every provision herein is intended to be severable. In any clause, phrase, or provision or portion of this Mortgage or the application of this Mortgage to any particular or part of this Mortgage, if any provision of this Mortgage is held to be invalid or unconstitutional under applicable law, the remaining clauses, phrases, court of competent jurisdiction to be valid or unconstitutional under applicable law, the remaining clauses, phrases, provisions and portions of this Mortgage shall be valid and enforceable to the fullest extent permitted by law.

Any use or attempted use by Borrower of the revolving line of credit evidenced by the Note after such an Event of Default shall constitute a separate Event of Default.

As an alternative to declaring all sums secured by this Mortgage to be immediately due and payable, Lender may waive its option to accelerate and agree in writing, prior to close of the sale or transfer to the transferee's assumption of the outstanding obligation under the Note, on terms satisfactory to Lender, subject to Lender's right, described in Paragraph 6.D of the Note, to freeze or reduce the line of credit. Lender's acceptance of the transferee's assumption of the obligation under Note shall not release Borrower from any of obligations under the Note and the Credit Document, and Borrower shall assume the status of the guarantor of the Note until paid in full. Borrower understands that Lender will not permit the assumption of the outstanding balance under the Note in any event and will declare the entire outstanding principal balance plus accrued interest and other charges due to be immediately due and payable (see Paragraph 17 hereof), unless (i) Borrower has submitted to Lender a written acknowledgement from the transferee that the transferee has received (a) a copy of each of the Credit Documents and (b) notice of the amount of Borrower's outstanding principal balance on the line of credit; (ii) Borrower has submitted to Lender a written acknowledgement from transferee that transferee has received such material and understands that Lender's security interest reflected by this Mortgage and the Security Agreement, if any, will remain on the Property and the Beneficial Interest, if any, until the entire outstanding principal balance of Borrower's line of credit as of the date of such sale or transfer or promise, plus any subsequent borrowing made under Borrower's line of credit before Lender has actual knowledge of the sale or transfer, together with accrued interest and other charges, is paid in full; (iii) Borrower causes to be submitted to Lender from the transferee a loan application as required by Lender so that Lender may evaluate the creditworthiness of the transferee as if a new loan were being made to the transferee; and (iv) Lender does not in its sole opinion, believe that (a) its security will be adversely affected, or (b) a breach of any promise or agreement in this Mortgage or the Security Agreement, if any, will occur or (c) such transfer will permit the acceleration of any loan which has priority in right of payment over the indebtedness evidenced by the Note. Further advances on the line of credit will cease as of the date of the written assumption agreement signed by the transferee and Lender. The transferee and Borrower shall retain the right to repay the Note before the final payment date set forth in Paragraph 4 of the Note, in whole or in part, at any time without premium or penalty.

17. **ACCELERATION; REMEDIES (INCLUDING FREEZING THE LINE).** Upon the existence of an Event of Default Lender may, at its sole option, terminate the line, declare all of the sums secured by this Mortgage to be immediately due and payable without further demand, and invoke any remedies permitted by applicable law.

22. **TIME OF THE ESSENCE.** Time is of the essence to this Mortgage and all provisions relating thereto are to be strictly construed.

21. **INCORPORATION OF TERMS.** All of the terms, conditions and provisions of the Note are by this reference incorporated herein without further notice to Borrower.

20. **REOUEST FOR NOTICES.** Borrower requests that copies of any notice of default be addressed to Borrower and sent to the Propertry Address. Lender requests that copies of notices of default, sale and foreclosure from the holder of any lien which has priority over this Mortgage be sent to Lender's address, as set forth on a page one of this Mortgage.

19. **RELEASE.** Upon payment and discharge of all sums secured by this Mortgage, and termination of the account, this Mortgage shall become null and void and Lender shall release this Mortgage to Borrower.

Upon acceleration under Paragraph 17 hereof, or abandonment, or a default receiver, or any time without notice, by agent or by judicially appointed receiver, and without regard to the adequacy of any security for the indebtedness secured by this Mortgage, shall be entitled to enter upon, take possession of, and manage the Property, and in its own name sue for or collect the rents of the Property, including those past due. All rents collected by Lender or the receiver shall be applied first to payment of the costs of operation and collection of the Property and collection of rents, including, but not limited to, receivers fees, premiums on receivables, attorney's fees, and then to the sums accrued by this Mortgage. Lender and the receiver shall be liable to account only for those sums actually received. The entire amount taken possession of the Property and application of the rents to the above purposes shall not cure or waive any event of default or notice of default hereunder or invalidate any act done pursuant to such notice.

18. **ASSIGNMENT OF RENTS; APPORTIONMENT OF RECEIVER, LENDER IN POSSESSION.** As additional security hereunder, Borrower hereby assigns to Lender the rents of the Property, provided that prior to date upon the occurrence of an Event of Default, Lender is advanced the amount of credit principal repayment due and payable.

If Lender reduces the line of credit, Lender shall notify Borrower, in the manner provided in Paragraph 11 of this Mortgage, within three (3) days after such action has been taken. Such notice shall specify: (i) the reasons for such reduction; (ii) the new credit limit, if the credit line has been reduced; and (iii) that any remittance of the credit privilege fees must by repaid at the new credit limit, if the credit line has been reduced; and (iv) the date of credit at Lender will remit the line of credit to Borrower's request if the event of default giving rise to such reduction or freeze occurs again. Lender will reduce the line of credit at Lender's discretion until the final payment date set forth in Paragraph 4 of the Note, to accelerate the final payment of credit or any Event of Default is then existing. If the line of Credit is frozen or reduced, Borrower is not obligated to repay the outstanding principal balance until the final payment date set forth in Paragraph 4 of the Note, provided that Lender will still have the right, in accordance with the terms of the Note, to accelerate the final payment of the line of credit if credit principal, interest or other events that would give Lender the right to freeze or reduce the line of credit occur again. Lender is advanced the amount of credit principal repayment due and payable.

As additional specific protection, notwithstanding any other term of the Note, Lender, without declaring or asserting under the Note, may cancel Borrower's right to any future advances under the Note, if the line of credit is reduced by 120% of the line of credit evidenced by the Note; (vi) Lender is notified by its regularity agency that the maximum interest rate permitted to be charged by Lender under the Note is reached; or (vii) the Note constitutes an usury and unsound practice; or (viii) the maximum interest rate permitted to be charged by Lender under the Note is exceeded by the Note; (ix) Lender is notified by its regularity agency that the maximum interest rate permitted to be charged by Lender under the Note is reached; or (x) the Note is declared illegal by a court of law.
