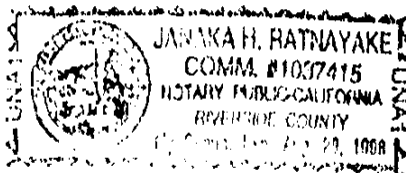

LEGAL DESCRIPTION FOR LOT 27 (4463 FOUR WINDS LANE):

That part of Sub-Lot "K" of Lot 1 in FOUR WINDS OF NORTHBROOK, being a subdivision of part of the Northeast 1/4 of Section 1, Township 42 North, Range 11 East of the Third Principal Meridian, according to the plat thereof recorded June 12, 1990 as Document No. 90-277717, bounded by a line described as follows: Commencing the Southwest corner of said Sub-Lot "K"; thence North 00°00'08" West, 47.33 feet to the point of beginning of the parcel to be described; thence North 00°00'08" West, 38.33 feet; thence North 82°29'52" East, 132.02 feet to a point of curvature; thence Southwesterly along the arc of a circle, being convex Southeasterly and having a radius of 25.00 feet, an arc distance of 14.96 feet (the chord of which arc bears South 08°13'15" West and measures 14.74 feet) to a point of reverse curvature; thence Southwesterly along the arc of a circle, being convex Northwesterly and having a radius of 60.00 feet, an arc distance of 25.64 feet (the chord of which arc bears South 13°07'38" West and measures 25.44 feet); thence South 82°29'52" West, 124.06 feet to the point of beginning, in Cook County, Illinois.
