

MEMORANDUM OF AGREEMENT OF ASSIGNMENT

WITNESSETH:

WHEREAS, Sellers and the Company are parties to that certain AGREFMENT OF ASSIGNMENT dated March 16, 1996 (the "Agreement of Arsonment") whereby, among other things, Sellers jointly and severally sold, assigned, transferred, set over, and conveyed to the Company the following personal property, hereinafter collectively referred to as the "Madsen Assets":

The Memorandum of Judgment regarding the Judgment (the "Memorandum") entered on June 18, 1993 in that certain lawsuit identified by the following caption: Postal Instant Press, Inc. and PIP Capital, Inc., Plaintiff, vs. Dale Madsen and Marilyn Madsen, Defendant, in the United States District Court for the Northern District of Illinois, Eastern Division, Case No. 91 C 6910, filed and recorded with the Cook County, Illinois Recorder of Deeds (the "Cook County Recorder") on June 22, 1993 as Document No. 93473876 and on January 24, 1995 as Document No. 95052367.

All right, title, and interest of Sellers in, to, and under the real property owned by the Madsens and commonly known as 2988 East 173rd Place, Lansing, Illinois, permanent index number 30-30-215-059-0000 (the "Property"), legally described as follows:

Lot 8 in Lake View Manor being a subdivision of the Southwest 1/4 of the Northeast 1/4 of Section 30, Township 36 North, Range 15 East of the Third Principal Meridian, in Cook County, Illinois.

The Sheriff's Certificate of Levy regarding the Property (the "Certificate of Levy") executed by the Sheriff of Cook County, Illinois (the "Sheriff"), filed and recorded with the Cook County Recorder on May 2, 1995 as Document No. 95288591.

The Certificate of Sale dated February 29, 1996 regarding the Property issued by the Sheriff to the Sellers (the "Certificate of Sale"), filed and recorded with the Cook County Recorder on February 29, 1996 as Document No. 96137249.

All right, title, and interest of the Sellers in, to, and under the Judgment, the Certificate of Levy, the Certificate of Sale, the Property, and the lawsuits, legal proceedings, and all other rights and powers connected therewith or relaced thereto.

WHEREAS, Sellers and the Company desire and have agreed to create, enter into, execute, acknowledge, file, and record this Memorandum Agreement to further evidence and confirm the Agreement of Assignment and the transfer of the Madsen Assets effected thereby.

NOW, THEREFORE, for and in consideration of the mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of all of which are hereby acknowledged by each party hereto to each other party hereto, it is agreed as follows:

AGREEMENT

1. Sellers hereby jointly and severally represent, warrant, acknowledge, confirm and agree that they have, in the Agreement Of Assignment, irrevocably sold, assigned, transferred, and conveyed to the Company all of the right, title and interest of the Sellers in, to, and under the Madsen Assets.

- 2. All of the provisions of the Agreement Of Assignment are hereby incorporated herein by this reference and made a part hereof, with the same force and effect as if set forth herein at length. A copy of the Agreement Of Assignment is on file at:
 - A. the offices of local counsel to the Sellers, Stoin & Rotman, at 105 West Madison Street, Chicago, Illinois 60602; and
 - B. the offices of counsel to the Company, Rosenthal and Schanfield, at 55 East Monroe Street, 46th Floor, Chicago, Illinois 60603, Attention: Mr. Joel C. Lavin.

The Agreement Of Assignment contains, among other things, various provisions relating to the Madsen Assets, and other matters. The provisions of this Memorandum Agreement are not intended and do not in any way modify, alter, or amend the Agreement Of Assignment or any of its terms. Reference should be made to the Agreement Of Assignment in connection with any matter concerning or relating to the transfer of the Madsen Assets by Sellers to the Company.

- 3. This Memorandum Agreement is binding upon and inures to the benefit of the parties hereto and their respective successors and assigns.
- 4. This Memorandum Agreement shall be filed with the Cook County Recorder immediately after it has been executed and acknowledged by the parties hereto.

IN WITNESS WHEREOF, the parties hereto have entered into, executed, and delivered this Memorandum Of Agreement Of Assignment as of the date first above written.
