This Trust Deed consists of seven pages (3 pages having two sides). The covenants, conditions and provisions appearing on subsequent pages are incorporated herein by reference and are a part hereof and shall be binding on the mortgagor, his heirs, successors and assigns.

THIS INDENTURE, made this 17 day of June, 1996, between FRED TOKOWITZ (herein referred to as "Mortgagor") and THE CHICAGO TRUST COMPANY, an Illinois corporation doing business in Chicago, Illinois, (herein referred to as "Trustee");

WITN ESSETH:

THAT, WHEREAS the Mortgagor is justly indebted to the legal holders of the Installment Note of the Mortgagor (the "Note") hereing her described, (said legal holder or holders being herein referred to as "holders of the Note"), ir. the total principal sum of FIVE HUNDRED THOUSAND DOLLARS (\$ 500,000), evidenced by the Note of even date herewith, made payable to the Order of The Fred Tokowitz T ust, Muriel Hoffman, Randall E. Green and George Green, as acting co-trustees thereunder and achivered, in and by which Note the Mortgagor promises to pay the said total principal sum and interest from, July 1, 1996, on the balance of principal remaining from time to time unpaid at the rate of Seven per cent (7.0%) per annum, in installments (including principal and interest), as follows: Three Thousand, Five Hundred Thirty Three and 90/100 Dollars (\$3,533.90) or more on the 1st day of July 1996, and Three Thousand, Five Hundred Thirty Three and 90/100 Dollars (\$3,533.90). Dollars or more on the day of each thereafter until said Note is fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due on the 1st day of July, 2021. All such payments on account of the indebtedness evidenced by said Note to be first applied to interest on the unpaid principal balance and the remainder to principal; all of said principal and interest being made payable at such banking house or trust company in Chicago, Illinois, as holders of the Note may, from time to time, in writing appoint, and in the absence of such appointment, then at the at the business office of Mr. Randall E. Green, in St. Louis, Missouri, or at such other place or places as the said Randall E. Green shall from time to time direct in written instrument delivered to the Mortgagor;

NOW, THEREFORE, the Mortgagor to secure the payment of the said principal sum of money and said interest in accordance with the terms, provisions and limitations of this Trust Deed, and the performance of the covenants and agreements herein contained, by the Mortgagor to be performed, and also in the consideration of the sum of One Dollar (\$1.00) in hand paid, the receipt whereof is hereby acknowledged, does by these presents CONVEY and WARRANT unto the Trustee, its successors and assigns, the following described Real Estate and all of its

estate, right, title and interest therein, situate, lying and being in the, County of Cook and State of Illinois, to wit:

Unit 4503, as delineated on survey of the following described real estate (herein called "Condominium Property") in Cook County, Illinois: Lots 4 to 18, both inclusive, and including Lots 7-"A", 7-"B", 7-"C", 7-"D", 7- "E", 7-"F", 11-"A" and 11-"B" in Marban Resubdivision, being a Subdivision of a Part of Block 20 in Canal Trustees' Subdivision of the South fractional 1/4 of Section 3, Township 39 North, Range 14, East of the Third Principal Meridian, according to the Plat of said Marban Resubdivision, recorded December 30, 1975, with the Cook County Recorder of Deeds, as Document 23339677; which Survey (herein called "Survey") is attached as Exhibit "A" to Declaration of Condominium Ownership, Easements, Covenants and Restrictions and By-Laws for 180 East Pearson Street Condominum, Chicago, Illinois (herein called "Declaration"), recorded in the Office of the Cook County Recorder of Deeds, on March 29, 1976, as Document 23/37350, as amended from time to time, together with its undivided percentage interest in the common elements, in Cook County, Illinois.

TOGETHER with all improvements renements, easements, fixtures and appurtenances thereto belonging and all apparatus, equipment or articles now or hereafter therein or thereon used to supply heat, gas, air conditioning, water, light, power, refrigeration (whether single units or centrally controlled), and ventilation, including (v ithout restricting the foregoing), screens, window shades, storm doors and windows, floor coverings, refrigerators, stoves, and water heaters. All of the foregoing are declared to be a part of caid real estate whether physically attached thereto or not, and it is agreed that all similar apparatus, equipment or articles hereafter placed in the premises by the mortgagor or his successors or assigns shall be considered as constituting part of the real estate.

TO HAVE AND TO HOLD the premises unto the said Trustee, its successors and assigns, forever, for the purposes, and upon the uses and trusts herein set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Liws of the State of Illinois, which said rights and benefits the Mortgagor does hereby expressly release and waive.

THE COVENANTS, CONDITIONS AND PROVISIONS PREVIOUSLY REFERRED TO AND INCORPORATED HEREIN BY REFERENCE ARE:

- 1. Mortgagor shall (a) promptly repair, restore and rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (b) keep said premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordinated to the lien hereof; (c) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the Note, (d) complete within a reasonable time any buildings now or at any time in process of erection upon said premises; (e) comply with all require nents of law or municipal ordinances with respect to the premises and the use thereof; (f) make no material alterations in said premises except as required by law or municipal ordinance.
- 2. Morgagor shall pay, before any penalty attaches, all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the Note duplicate receipts therefor. To prevent default hereunder, Mortgagor shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagor desires to contest.
- 3. Mortgagor shall keef the premises and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning or windstorm (and flood damage, where the lender is required by law to have its loan so insured) under policies providing for payment by the insurance companies of moneys sufficient emone to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the holders of the Note, under insurance policies payable, in case of loss or damage, to Trustee for the benefit of the holders of the Note, such rights to be evidenced by the standard mortgage clause to be attached to each policy; and shall deliver all policies, including additional and renewal policies, to holders of the Note, and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.
- In case of default therein, Trustee or the holders of 'ne Note, or of any of the may, but need not, make any payment or perform any act hereinbefore required of Mortgagor in any faith and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or setue any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting said premises or contest any tax or assessment. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including attorneys' fees, and any other moneys advanced by Trustee or the holders of the Note, or of any of them, to protect the mortgaged premises and the lien hereof, plus reasonable compensation to Trustee for each matter concerning which action herein authorized may be taken, shall be so much additional indebtedness secured hereby and shall he come immediately due and payable without notice and with interest thereon at the highest pre maturity rate set forth therein. Inaction of Trustee or holders of the Note shall never be considered as a waiver of any right accruing to them on account of any default hereunder on the part of the Mortgagor.
- 5. The Trustee or the holders of the Note hereby secured making any payment hereby authorized relating to taxes or assessments, may do so according to any bill, statement or estimate procured from the appropriate public office without injury into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof.
- 6. Mortgagor shall pay each item of indebtedness herein mentioned, both principal and interest, when due according to the terms hereof. At the option of the holders of the Note, or any of them, and without notice to Mortgagor, all unpaid indebtedness secured by this Trust Deed shall, notwithstanding anything in the Notes or in this Trust Deed to the contrary, become due and payable (a) immediately in the case of default in making payment of any of the Note, or (b) when default shall

occur and continue for three days in the payment of any interest or in the performance of any other agreement of the Mortgagor herein contained.

- When the indebtedness hereby secured shall become due whether by acceleration or otherwise, holders of the Note, or any of them, or Trustee shall have the right to foreclose the lien hereof. In any suit to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and expenses, which may be paid or incurred by or on behalf of Trustee or holders of the Note, or any of them, for attorneys' fees, Trustee's fees, appraiser's fees, outlays for documentary and expert evidence, stenographers' charges, publication costs and costs (which may be estimated as to items to be expended after entry of the decree) of procuring all such abstrac's of title, title searches and examinations, guarantee policies, Torrens certificates, and similar data and assurances with respect to tile as Trustee or holders of the Note, or any of them, may deem to be reasonably necessary either to prosecute such suit or to evidence to bidders at any sale which may be had pursuant to such decree the true condition of the title to or the value of the premises. All expenditures and expanses of the nature in this paragraph mentioned shall become so much additional indebtedness secured herery and immediately due and payable, with interest thereon at a rate equivalent to the highest pre-maturity rate set forth therein, when paid or incurred by Trustee or holders of the Note in connection with (a) any proceeding including probate and bankruptcy proceedings, to which either of from shall be a party, either as plaintiff, claimant or defendant, by reason of this Trust Deed or any indefied less hereby secured; or (b) preparations for the commencement of any suit for the foreclosure hereof after accrual of such right to foreclose whether or not actually commenced; or (c) preparations for the defense of any threatened suit or proceeding which might affect the premises or the security hereof, whether or not actually commenced.
- 8. The proceeds of any foreclosure sale of the premises shall be distributed and applied in the following order of priority: First, on account of all costs and expenses incident to the foreclosure proceedings, including all such items as are mentioned in the preceding paragraph hereof; second, all other items which under the terms hereof constitute secured indebtedness additional to that evidenced by the Note with interest thereon as herein provided; third, all principal and interest remaining unpaid on the Note; fourth, any overplus to Mortgagor, his leits, legal representatives or assigns, as his rights may appear.
- Upon, or at any time after the filing of a bill to for close this Trust Deed, the court in which such bill is filed may appoint a receiver of said premises. Such appointment may be made either before or after sale, without notice, without regard to the solvency or insolvency of the Mortgagor at the time of application for such receiver and without regard to the then van e of the premises or whether the same shall be then occupied as a homestead or not and the Trustee hereunder may be appointed as such receiver. Such receiver shall have the power to collect the rents issues and profits of said premises during the pendency of such foreclosure suit and, in case of a sale and a deficiency, during the full statutory period of redemption, whether there be redemption or not, as well as ruring any further times when Mortgagor, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may be necessary or are usual in sum cases for the protection, possession, control, management, and operation of the premises during the whole of said period. The Court from time to time may authorize the receiver to apply the net income in his hands in payment in whole or in part of: (a) The indebtedness secured hereby, or by any decree foreclosing this Trust Deed, or any tax, special assessment or other lien which may be or become superior to the lien hereof or of such decree, provided such application is made prior to foreclosure sale; (b) the deficiency in case of sale and deficiency.
- in case or sale and deticiency.

 10. No action for the enforcement of the lien or of any provision hereof shall be subject to any defense which would not be good and available to the party interposing same in an action at law upon the Note hereby secured.
- 11. Trustee or the holders of the Note, or of any of them, shall have the right to inspect the premises at all reasonable times and access thereto shall be permitted for that purpose.

- 12. Trustee has no duty to examine the title, location, existence, or condition of the Premises, or to inquire into the validity of the signatures or the identity capacity, or authority of the signatories on the Note or the Trust Deed, nor shall Trustee be obligated to record this Trust Deed or to exercise any power herein given unless expressly obligated by the terms hereof, nor be liable for any acts or omissions hereunder, except in case of its own gross negligence or misconduct or that of the agents or employees of Trustee, and it may require indemnities satisfactory to it before exercising any power herein given.
- presentation of satisfactory evidence that all indebtedness secured by this Trust Deed has been fully paid; and Trus'ee may execute and deliver a release hereof to and at the request of any person who shall either bettere or after maturity thereof, produce and exhibit to Trustee the Note, representing that all indebtedness hereby secured has been paid, which representation Trustee may accept as true without inquiry. Where a release is requested of a successor trustee, such successor trustee may accept as the genuine Note her an described any Note which bear an identification number purporting to be placed thereon by a price to astee hereunder or which conform in substance with the description herein contained of the Note and which purports to be executed by the persons herein designated as the makers thereof; and where the release is requested of the original trustee and it has never placed its identification number on the Note described herein, it may accept as the genuine Note herein described any Note which may be presented and which conform in substance with the description herein contained of the Note and which purport to be executed by the persons herein designated as makers thereof
- 14. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrar of Titles in which this instrument shall have been recorded or filed. Any Successor in Trust hereunder shall have the identical title, powers and authority as are herein given Trustee.
- 15. This Trust Deed and all provisions here f, shall extend to the be binding upon Mortgagor and all persons claiming under or through Mortgagor, and the word "Mortgagor" when used herein shall include all such persons and all persons liable for the payment of the indebtedness or any part thereof, whether or not such persons shall have executed the Notes or this Trust Deed.
- 16. Before releasing this Trust Deed, Trustee or successor shall receive for its services a fee as determined by its rate schedule in effect when the release deed it issued. Trustee of successor shall, be entitled to reasonable compensation for any other act or service performed under any provisions of this trust deed.

The provisions of the "Trust and Trustees Act" of the State of Illinois shall be applicable to this Trust Deed.
